

ORDINANCE NO. 365-1981

AN ORDINANCE REPEALING ORDINANCE 348-1980 AND SECTIONS 4(B)(1) AND 4(B)(3) OF ORDINANCE 291-1976, AND RAISING THE WATER RATES AND SEWER RATES TO ALL CUSTOMERS IN DRY RIDGE, KENTUCKY.

WHEREAS, the water rates to the customers of Dry Ridge must yield sufficient revenue to pay for the water consumed, and maintenance and operation costs of the system, and a reserve for emergencies, and

WHEREAS, the sewer rates to the customers of Dry Ridge must yield a sufficient revenue to pay for the water consumed in the Dry Ridge sewer plant,

NOW THEREFORE BE IT ORDAINED BY THE CITY OF DRY RIDGE:

SECTION ONE

Ordinance Number 348-1980 is hereby repealed.

SECTION TWO

Sections 4(B)(1) and 4(B)(3) of Ordinance Number 291-1976 are hereby repealed.

SECTION THREE

The minimum water bill shall be EIGHT DOLLARS (\$8.00) for the first TWO THOUSAND GALLONS (2,000) or fraction thereof used each month. The rate of ONE DOLLAR SIXTY-FIVE CENTS (\$1.65) per thousand gallons shall apply to the next EIGHT THOUSAND GALLONS (8,000) consumed over the minimum each month, and the rate of ONE DOLLAR FORTY-TWO CENTS (\$1.42) per thousand gallons shall apply to all water consumed in excess of TEN THOUSAND GALLONS (10,000) each month.

SECTION FOUR

The minimum monthly bill for sewer service, including surcharge, to residential customers shall be ELEVEN DOLLARS AND SIXTY CENTS (\$11.60), and each such customer shall be entitled in each month to discharge water into the municipal sewer system based upon water usage of TWO THOUSAND GALLONS (2,000) or less for such minimum sewer charge of ELEVEN DOLLARS AND SIXTY CENTS (\$11.60), and an additional charge of TWO DOLLARS FIFTY CENTS (\$2.50) shall be applied to each water usage of

ONE THOUSAND GALLONS (1,000) over the minimum usage of TWO THOUSAND GALLONS (2,000) ; and the minimum monthly bill for sewer service, including surcharge, to commercial customers shall be TWENTY DOLLARS AND SEVENTY-FIVE CENTS (\$20.75), and each customer shall be entitled in each month to discharge water into the municipal sewer system based upon water usage of TWO THOUSAND GALLONS (2,000) or less for such minimum sewer charge of TWENTY DOLLARS AND SEVENTY -FIVE CENTS (\$20.75), and an additional charge of TWO DOLLARS FIFTY CENTS (\$2.50) shall be applied to each water usage of ONE THOUSAND GALLONS (1,000) over the minimum usage of TWO THOUSAND GALLONS (2,000)

SECTION FIVE

This Ordinance shall go into effect August 1, 1981.
