

ORDINANCE NO. 385-1983

AN ORDINANCE AMENDING THE BUDGET FOR THE CITY OF DRY RIDGE, KENTUCKY FOR THE FISCAL YEAR , JULY 1982 - JUNE 1983, WHICH AMENDMENT IS NECESSITATED BECAUSE OF THE AVAILABILITY OF ACTUAL RATHER THAN ESTIMATED FIGURES.
