

ORDINANCE NO. 430-1988

AN ORDINANCE OF THE CITY OF DRY RIDGE, KENTUCKY PROHIBITING THE PARKING, STANDING, STOPPING OR STORAGE OF VEHICLES UPON KENTUCKY HIGHWAY NO. 2944, KNOWN AS FRONTAGE-SERVICE ROAD #6

WHEREAS, the City of Dry Ridge has been requested by the proper officials of the Commonwealth of Kentucky, Department of Transportation, Division of Traffic Control to eliminate the parking, standing, stopping or storage of motor vehicles or vehicles along Kentucky Highway No. 2944 to so improve the flow of traffic within the City; and

WHEREAS, this action is deemed necessary by this City Council in order to so protect the health and welfare of its citizens and residents and others using the said roadway above.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF DRY RIDGE:

SECTION ONE

No owner or operator of any vehicle or motor vehicle shall, at any time, so permit the same to be parked, stopped, or left standing or stored or abandoned on or upon to paved-covered portion or right of way, or both, of Kentucky Highway No. 2944 from its intersection with Broadway Street/Taft Highway (Kentucky Highway No. 22) and therefrom in a general, northerly direction on both the westerly and easterly sides-boundaries of the right of way and/or the paved-covered portion and the course of Kentucky Highway No. 2944 to the present or future line or point defining the then and incorporated limits of the City of Dry Ridge, Kentucky.

SECTION TWO

Any person, firm or corporation found guilty of violating the provisions of this Ordinance shall be fined not less than Twenty Dollars (\$20.00) nor more than One Hundred Dollars (\$100.00) for each offense together with any costs, charges, fees or other sanctions or conditions as may be so imposed by the appropriate Court of Justice of the Commonwealth of Kentucky.

SECTION THREE

The said Commonwealth of Kentucky, Department of Transportation, Bureau or Divi-

sion of Traffic Control or any other department, division, bureau, agency or cabinet of or within the Commonwealth of Kentucky having lawful authority or jurisdiction as to matters germane to highways, traffic regulation or control or the due enforcement of the laws, statutes or regulations related to same, each, jointly and severally, be and the same hereby and hereunder shall be so authorized and empowered by appropriate means or methods to more specifically determine, delineate and so otherwise designate whereupon and whereat along the course and right of way of Kentucky Highway No. 2944 to place signs or duly mark the roadway giving due notice of the actions involving the prohibitions as to parking, inter alia, of motor vehicles and vehicles hereinabove so provided by this Ordinance and to so further enforce the same in the Courts of Justices of this state or county or elsewhere.

#### SECTION FOUR

All ordinances, resolutions or orders, or parts thereof, in conflict with the herein Ordinance, are to the extent of any such conflict, hereby and hereunder so deemed and declared to be suspended and unenforceable as to Kentucky Highway No. 2944.

#### SECTION FIVE

The several sections, parts and provisions of this Ordinance herein are so hereby deemed and declared to be severable and if any section, part, provision, clause or sentence of this Ordinance be determined to be invalid, unenforceable or unconstitutional, then such declaration or finding shall not so effect the remaining parts or provisions of this Ordinance, all to remain in full force and effect to be duly applied and enforced.

#### SECTION SIX

This Ordinance shall become effective, applicable and duly enforceable when so duly read and voted upon by Council, passed and ordered published and so published as required by law.
