

ORDINANCE NO. 469-1991

AN ORDINANCE OF THE CITY OF DRY RIDGE, KENTUCKY, ESTABLISHING AND LEVYING A CHARGE AND FEE FOR RESIDENTIAL WASTE COLLECTION AND REMOVAL SERVICES SO PROVIDED BY THE CITY OF DRY RIDGE TO ITS RESIDENTS ON A WEEKLY BASIS.

WHEREAS, the City of Dry Ridge provides weekly residential waste collection and removal services to its residents residing within the incorporated limits of the city;

WHEREAS, the City of Dry Ridge by process of competitive bid has recently entered into an agreement with a waste collection and removal service company concerning such residential waste collection and removal services to be provided to the city's residents each calendar week during the term of the aforesaid agreement;

WHEREAS, the charge and cost of such residential waste collection and removal services payable by the city to the said waste collection and removal company has been increased over the amount now charged to the city which new costs and charges payable by the city to the provider are to be effective as of July 1, 1991, and the added costs and charges for such weekly residential waste collection and removal service cannot be absorbed by the city and must be passed onto the city's residents; and

WHEREAS, the Mayor and City Council of the City of Dry Ridge, Kentucky, have so declared an emergency situation to exist concerning the due enactment of this ordinance sufficient to negate two separate readings of this ordinance at separate meeting of the Dry Ridge City Council as required by statute in order for the charges and costs set forth hereinafter to be charged to the city's residential waste collection and removal customers to be of even date with the aforesaid waste collection and removal contract and to permit such costs and charges for the herein services to be entered by the City Clerk into the city's utilities billing system and timely remitted to city residents for timely payment with the vote of the Dry Ridge City Council on the foregoing emergency situation as to the enactment of this ordinance so suspending the requirement of two separate readings of the herein ordinance at two separate meetings of the Dry Ridge City Council being as follows, to-wit:

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF DRY RIDGE AS FOLLOWS:

SECTION ONE

Beginning on July 1, 1991, the cost and charge for weekly residential waste collection and removal services provided by the City of Dry Ridge to the city's residential users shall be the sum and amount of FOUR DOLLARS AND SEVENTY-FIVE CENTS (\$4.75) payable each calendar month and enumerated on the user's utility bill or other manner of bill or statement prepared and forwarded by the City Clerk of the City of Dry Ridge to such user.

SECTION TWO

All previous ordinances, laws, official entries, enactments or due orders of the city in conflict with Section One hereof be and the same are hereby repealed.


SECTION THREE

This ordinance shall become effective as of July 1, 1991, with it being hereby found, deemed and declared that by vote affirmative and sufficient by the City Council of the City of Dry Ridge that an emergency situation has been found and so duly declared so thereby negating and waiving the statutory requirement of two separate readings of the herein ordinance at two separate meetings of Council.

First Reading: July 1, 1991


Second Reading: July 1, 1991
