

ORDINANCE NO. 497-1993

AN ORDINANCE OF THE CITY OF DRY RIDGE, KENTUCKY, SO ESTABLISHING THE TARIFF, RATE AND CHARGE FOR SANITARY WATER SERVICES PROVIDED TO ALL CUSTOMERS IN THE CITY OF DRY RIDGE AND AMENDING CITY OF DRY ORDINANCE NO. 480-1992.

WHEREAS, the tariff and water rates charged to customers of the City of Dry Ridge must yield sufficient revenues to pay the costs incurred by the city to purchase water from the city's supplier and to maintain the city's water system and facilities; and

WHEREAS, the cost for water supplied to the City of Dry Ridge is to be increased and the City Council of the City of Dry Ridge has determined that a change and amendment to the heretofore established tariff, rates and charges for sanitary water services provided to the city's customers is required to pay such increased costs to the city and hereby equitably defer such increased cost among the city's class of water customers.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DRY RIDGE, KENTUCKY, that City of Dry Ridge Ordinance No. 480-1992 is so hereby amended and the tariff, rates and charges for sanitary water services provided to the city's customers is hereby fixed and established as follows:

"SECTION THREE"

Section Three of City of Dry Ridge Ordinance No. 480-1992 heretofore enacted and ordained is amended as follows:

(2) The minimum water bill shall be ~~Twelve-Dollars-and-Nineteen-Cents--(\$12.19)~~ Ten Dollars and Fifty Cents (\$10.50) for the first two thousand (2,000) gallons or fraction thereof used each month. The rate of ~~Two Dollars and Sixty-Eight-Cents--(\$2.68)~~ Two Dollars and Forty-Seven Cents (\$2.47) per thousand gallons shall apply to the next eight thousand gallons consumed over the minimum each month; and at the rate of ~~Two-Dollars-and-Thirty-Four-Cents--(\$2.34)~~ Two Dollars and Sixteen Cents (\$2.16) per thousand gallons shall apply to all water consumed in excess of ten thousand (10,000) gallons each month.

"SECTION FOUR"

The tariff, rates and charges for sanitary water services provided to customers of the City of Dry Ridge as now established and fixed in Section Three (2) of this Ordinance above, shall be effective upon due passage and publication of this Ordinance as required by law with such established and fixed rates being applied to sanitary water consumed by the customers of the City of Dry Ridge beginning 1 May 1993 and to be levied, charged and reflected upon customers' bills issued during the June 1993 billing.
