

ORDINANCE NO. 638-2003

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, GRANTING UNTO THE SAID CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, AND ITS PERSONNEL, AGENTS AND ASSIGNS THE AUTHORITIES, CONSENTS, AND EASEMENTS, REQUISITE AND NECESSARY, TO SO (1) CONSTRUCT, ERECT AND INSTALL ALONG, WITHIN, OR UPON THE RIGHT-OF-WAY OR PAVED PORTIONS OF ELLEN-KAY DRIVE, A CITY STREET OR ROADWAY WITHIN THE CORPORATE LIMITS OF THE CITY OF DRY RIDGE, KENTUCKY, AN EXTENSION OF THE CITY'S SANITARY SEWERAGE/SEWER SYSTEM; AND (2) CONSTRUCT, ERECT AND INSTALL ALONG, WITHIN, OR UPON THE RIGHT-OF-WAY OR PAVED PORTIONS OF FASHION RIDGE ROAD, CURRY LANE AND THE FRONTAGE ROAD ALONG THE WESTERLY SIDE OF INTERSTATE HIGHWAY NO. 75 (I-75) (KENTUCKY STATE HIGHWAY NO. 2944), ALL BEING CITY STREETS OR ROADWAYS WITHIN THE CORPORATE LIMITS OF THE CITY OF DRY RIDGE, KENTUCKY, AN EXTENSION OF THE CITY'S MUNICIPAL WATER SYSTEM.

WHEREAS, the City maintains and operates both a municipal water system and a sewerage collection system which it intends to each expand by extending the water system out to the waters of Boltz Lake along Fashion Ridge Road, Curry Lane, and the Frontage Road (SR No. 2944); and extending the sewerage collection system to additional residents along Ellen-Kay Drive; and

WHEREAS, to accomplish and complete the above extensions of the City's water and sewerage collection systems, the City has obtained funds by loan and grant from the United States Department of Agriculture, Rural Development, which requires that consents and easements be had concerning and regarding the City streets, roadways and right-of-ways wherein or whereupon construction and installation is to made to complete the herein referred municipal projects; and

WHEREAS, the City Council of the City of Dry Ridge, Grant County, Kentucky, hereby and hereunder intends to give and grant the authorities, consents and easements necessary to and unto the City of Dry Ridge and its agents and assigns concerning and regarding the City's streets, roadways, and right-of-ways to make and complete the extensions of the City's municipal water system and municipal sewerage collection system.

BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, AS FOLLOWS:

Section One

The City Council of the City of Dry Ridge, Grant County, Kentucky, hereby gives and grants to and unto the said City of Dry Ridge, Grant County, Kentucky, and its personnel, agents and assigns, the authority, consent and easements, requisite and necessary, to extend the city's municipal sewerage collection system along the course and right-of-way of Ellen-Kay Drive, a street or roadway within the corporate limits of the City of Dry Ridge, and to install therein or thereupon all manner of service lines and fixtures necessary for the said project, all so approved and financed by loan or grant monies provide by the USDA/Rural Development.

Section Two

The City Council of the City of Dry Ridge, Grant County, Kentucky, hereby gives and grants to and unto the said City of Dry Ridge, Grant County, Kentucky, and its personnel, agents and assigns, the authority, consent and easements, requisite and necessary, to extend the city's municipal water system along the course and right-of-ways of Fashion Ridge Road, Curry Lane, and Frontage Road/SR No. 2944, streets and roadways within the corporate limits of the City of Dry Ridge, and to install therein or thereupon all manner of service lines and fixtures necessary for the said project, all so approved and financed by loan or grant monies provided by the USDA/Rural Development.
