

ORDINANCE NO. 791-2015

AN ORDINANCE OF THE CITY OF DRY RIDGE, KENTUCKY, CONCERNING THE CITY’S STREET AND ROADWAY SYSTEM CURRENT; IDENTIFYING SUCH STREETS AND ROADWAYS BY NAME; AND ESTABLISHING THE SPEED LIMITS AND TRAFFIC FLOW DIRECTIONS FOR SUCH STREETS AND ROADWAYS.

**BE IT HEREBY ORDAINED BY THE CITY OF DRY RIDGE, KENTUCKY, AS FOLLOWS:**

Article one

That the streets and roadways within the City of Dry Ridge Street System are fixed and identified by name with the speed limit and traffic directional flow for each street or roadway being fixed and established as follows, to-wit:
