Mayor Clay Crupper called the meeting to order at 5:30 p.m.

OLD BUSINESS

A. SECOND READING ORDINANCE 734-2008 REAL/PERSONAL TAX –

B. SECOND READING ORDINANCE 733-2008 AUTO/WATERCRAFT TAX

NEW BUSINESS

A. WATER CONTRACT (WITH WILLISMTOWN)

Council and Mayor Crupper had a brief discussion concerning the length of the contract extending to the year 2049. Council member Encil Webster pointed out the amount of years was a long time to commit, that Williamstown could raise the rate each year, and limit the amount of water we could purchase. Council member Encil Webster also stated the City of Dry Ridge is growing and it would be hard to predict water usage for 41 years. Council member Fred Money moved, Council member Encil Webster seconded to accept the water contract with the City of Williamstown. Motion carried Kenny Edmondson-yes, Fred Money-yes, Jason O'Nan-yes, Jamie Webster-yes, Encil Webster-abstained.

B. SEWER CONTRACT (WITH WILLIAMSTOWN)


Council member Jason O'Nan moved, Council member Fred Money moved to accept the sewer contract with the City of Williamstown. Motion carried Kenny Edmondson-yes, Fred Money-yes, Jason O'Nan-yes, Jamie Webster-yes, Encil Webster-abstained.

C. SEWER ORDINANCE SMOKE TESTING

Sewer Superintendent Ken Little explained what was involved with smoke testing and why he felt this was important to the City of Dry Ridge. Ken Little also stated this was a free service provided by Kentucky Rural Water. Ken Little presented a sample draft of the smoke testing ordinance and asked Michael Mulvey to give the ordinance a first reading. Council member Jason O'Nan asked Michael Mulvey to make the necessary changes to the sample ordinance before having a first reading and waiting until October 6, 2008.
