

ORDINANCE NO. 439-1989

AN ORDINANCE OF THE CITY OF DRY RIDGE AMENDING CITY ORDINANCES NO. 313, 1977 AND NO. 414-1987 FIXING, INTER ALIA, THE ANNUAL COMPENSATION OF THE CITY'S CHIEF EXECUTIVE OFFICER, THE MAYOR, FOR THE NEXT, ELECTIVE TERM OF OFFICE BEGINNING JANUARY 1, 1990.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF DRY RIDGE:

SECTION THREE

The duly elected Chief Executive Officer of the City of Dry Ridge, Kentucky, the Mayor, be and is hereby ordained and directed to receive as compensation for his or her service the sum of THREE THOUSAND FIVE HUNDRED DOLLARS (\$3,500.00) annually.


SECTION FOUR

That pursuant to KRS 83A.075(1) and (2), the annual compensation of the Mayor as fixed and ordained herein, may be adjusted to reflect changes in the consumer price index within the preceding year upon receipt from the Commonwealth of Kentucky, Department of Local Government of its computations regarding the consumer price index, but that any increase in the annual compensation paid to the Mayor shall be no greater than that computed by the Department of Local Government.

SECTION EIGHT

This ordinance shall become effective on January 1, 1990, being the beginning date of the next, elective term of office of the Mayor of Dry Ridge, Kentucky.

CERTIFICATION: I, Michael S. Mulvey, the undersigned, hereby certify that I am a duly licensed and practicing attorney at law and the attorney for the City of Dry Ridge, Kentucky, and that the foregoing is an accurate summary of the proceedings and the ordinance of the City of Dry Ridge fixing and establishing the salary and compensation to be received and paid to the City's Mayor for the elected term of office beginning January 1, 1990, and further allowing adjustments in said base compensation based upon changes in the consumer price index. Further, a full and complete text of this said ordinance is on file and of due record in the offices of the City of Dry Ridge, Kentucky.

ORDINANCE NO. 439-1989

AN ORDINANCE OF THE CITY OF DRY RIDGE AMENDING CITY ORDINANCES NO. 313, 1977 AND NO. 414-1987 FIXING, INTER ALIA, THE ANNUAL COMPENSATION OF THE CITY'S CHIEF EXECUTIVE OFFICER, THE MAYOR, FOR THE NEXT, ELECTIVE TERM OF OFFICE BEGINNING JANUARY 1, 1990.

WHEREAS, the City Council of the City of Dry Ridge desires and duly intends by this Ordinance to increase the annual compensation received by the office of the Mayor of the City of Dry Ridge for the next, elected term of office beginning January 1, 1990.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF DRY RIDGE:

SECTION ONE

That as heretofore provided and duly ordained by City of Dry Ridge Ordinance No. 414-1987, that City Ordinances No. 137, 155, 169 and 192 be and the same by reiteration are declared to be so hereby repealed effective as of January 1, 1988, as heretofore provided and ordained by Ordinance No. 414-1987 of the City of Dry Ridge.

SECTION TWO

That each duly elected member of the City's legislative body, except the Chief Executive of the City of Dry Ridge, be and the same are hereby ~~ordered-~~ ordained to receive as compensation for their services the sum of \$500.00 annually. Said compensation shall be paid annually at the last regular meeting of City Council of each calendar year.

SECTION THREE

The duly elected Chief Executive Officer of the City of Dry Ridge, Kentucky, the Mayor, be and is hereby ~~ordered~~ ordained and directed to receive as compensation for ~~his~~ his or her services the sum of ~~TWO-THOUSAND-DOLLARS-(\$2,000.00)~~ THREE THOUSAND FIVE HUNDRED DOLLARS (\$3,500.00) ~~per-year~~ annually. Said compensation shall be paid annually ~~at-the-end-of each-calendar-year-~~ at the last regular meeting of City Council of each calendar year .

"SECTION FOUR"

That pursuant to KRS 83A.075(1) and (2), the annual compensation of the City's Chief Executive Officer, the Mayor, as fixed and ordained in Section Three above, may be adjusted to reflect changes in the consumer price index within the preceding year upon receipt of such computations of the consumer price index from the Commonwealth of Kentucky, Department of Local Government, but that the increase in such annual compensation, if any, shall be no greater than that so computed by the Department of Local Government.

"SECTION FIVE"

All other city employees' salaries shall be fixed every two (2) years by the City Council of the City of Dry Ridge, Kentucky.

"SECTION SIX"

All ordinances and resolutions, or parts thereof, in conflict herewith are, to the extent of such conflict, hereby repealed.

"SECTION SEVEN"

If any section, clause or paragraph of this ordinance be declared to be invalid, such invalidity shall not effect the remaining sections, clauses or paragraphs hereof, it being hereby expressly declared that said remainder of said ordinance would be passed despite such invalidity.

SECTION EIGHT

This ordinance shall become effective on January 1, 1990, being the beginning date of the next, elective term of office of the City's Chief Executive Officer, the Mayor.
