

ORDINANCE NO. 453-1990

AN ORDINANCE OF THE CITY OF DRY RIDGE ESTABLISHING AN INCREASED RATE AND CHARGE FOR WATER DISPENSED AT THE CITY'S LOADING STATION ON THE EAST SIDE OF MEEKS ROAD WITHIN THE INCORPORATED LIMITS OF THE CITY OF DRY RIDGE AND AMENDING SECTIONS ONE, TWO AND THREE OF ORDINANCE NO. 441-1989 HERETOFORE DULY PASSED AND ORDAINED BY AND FOR THE CITY OF DRY RIDGE, KENTUCKY.

WHEREAS, the tariff and water rates charged to the customers of the City of Dry Ridge must yield sufficient revenues to pay for such water consumed and to service the costs incurred to maintain the city's water system and facilities; and whereas the cost and charges for water supplied to the City of Dry Ridge has increased and will continue to increase and, likewise, the costs incurred and expended by the City of Dry Ridge to maintain and operate the city's water system and facilities has increased and will continue to increase so requiring the city to pass such increased expenses and expenditures on to its customers since the city can no longer absorb and pay these increased and increasing costs and charges itself.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF DRY RIDGE:

SECTION ONE

The rate and charge present of Two Dollars and Fifty Cents (\$2.50) for each one thousand (1,000) gallons of water dispensed at the City's Water Station located on Meeks Road within the City of Dry Ridge, Kentucky, be and the same is hereby raised, increased, set and established at the rate and charge of Four Dollars (\$4.00) for each one thousand (1,000) gallons of water dispensed.

SECTION TWO

The herein increased rate and charge for water provided at the City's Water Station located on Meeks Road as set and established in Section One hereof, shall be fixed and effective as of the 1st day of April, 1990.

SECTION THREE

A. Section One of City of Dry Ridge Ordinance No. 441-1989 previously enacted and ordained establishing the rate and charge of \$2.50 for each one thousand (1,000) gal-

lons of water provided and dispensed at the city's water station be and the same is hereby amended and increased to the rate and charge of Four Dollars (\$4.00) for each one thousand (1,000) gallons of water dispensed as hereinabove established in Section One of this Ordinance with the remainder of the language set forth in Section One of Ordinance No. 441-1989 being omitted herefrom as the same is not now applicable.

B. Sections Two and Three of City of Dry Ridge Ordinance No. 441-1989 and the said language and provisions therein set forth are omitted herefrom as the same is not now applicable.

SECTION FOUR

This Ordinance shall become effective on the 1st day of April, 1990 or when the same be passed, ordained, approved and ordered published as required by law.
