

AN ORDINANCE OF THE CITY OF DRY RIDGE ESTABLISHING AND INCREASED RATE AND CHARGE FOR SANITARY SEWER SERVICES TO ALL CUSTOMERS IN DRY RIDGE, KENTUCKY, AND AMENDING CITY OF DRY RIDGE ORDINANCE NO. 368-1981.

WHEREAS, the tariff and sewage treatment rates charged to all customers of the City of Dry Ridge must yield sufficient revenues to pay the costs incurred by and charged to the City of Dry Ridge by the City of Williamstown for the treatment of sewage, waste waters and affluent which have heretofore been increased and will so continue to increase together with the costs and expenses necessary to maintain and operate the city's sewer system and facilities; and whereas since the City of Dry Ridge cannot continue to absorb and alone pay these increased and increasing expenditures and costs for treatment of sewage, waste water and affluent and to so maintain and operate the city's sewer system and facilities, such increased and increasing costs and expenses applicable to the treatment of waste affluent and to maintain and operate the city's sewer system must be passed onto the customers and users of the city's sanitary sewer services.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF DRY RIDGE:

SECTION ONE

Section Two of City of Dry Ridge Ordinance No. 368-1981 heretofore enacted and ordained and therein amending Section 4(B)(1) of Ordinance No. 219-1976 is amended as follows:

(1) Basic Monthly Rates.

Basic monthly rates for sewer services shall be based, insofar as possible, upon the quantity of water supplied to the respective building or premises as follows:

Number of Gallons of Water Consumption Per Month	Monthly Sewer Charge
First 2,000 gallons or less	\$5.60 (Minimum Monthly Charge)
All over 2,000 gallons	-\$2.50- <u>\$3.30</u> per 1,000 gallons

SECTION TWO

Section Three of City of Dry Ridge Ordinance No. 368-1981 heretofore enacted and ordained and therein amending Section 4(B)(2) of Ordinance No. 219-1977 is so amended as follows:

(2) Surcharge.

In addition to the basic monthly rates set out above, each residential customer of the municipal sewer system shall be required to pay a surcharge in the amount of \$6.00 per month, and each commercial customer of the system shall be required to pay a surcharge in the amount of \$13.15 per month. Also, in addition to the foregoing charges, Apartment owners and Mobile Home Park owners or any person/owner having a single water/sewer meter serving or measuring the usage of an apartment building, apartment complex, group of mobile homes/modular units or more than one place of repose, abode, residency, living quarters, house or home, all being hereby denoted or defined as a "dwelling unit" shall pay-TWO-DOLLARS-(\$2.00)- FOUR DOLLARS (\$4.00) per "dwelling unit".

SECTION THREE

Section Four of City of Dry Ridge Ordinance No. 368-1981 heretofore enacted and ordained and therein amending Section 4(B)(3) of Ordinance No. 219-1976 is amended as follows:

(3) Minimum Sewer Rates and Charges.

The minimum monthly bill for sewer services, including surcharge, to residential customers shall be-~~\$11.60~~- \$15.31 and each customer shall be entitled in each month to discharge water into the municipal sewer system based upon water usage of 2,000 gallons or less for such minimum sewer charge of-~~\$11.60~~- \$15.31; and the minimum monthly bill for sewer services, including surcharge, to commercial customers shall be ~~\$18.75~~- \$24.74 and each customer shall be entitled in each month to discharge water into the municipal sewer system based upon water usage of 2,000 gallons or less for

such minimum sewer charge of ~~-\$18.75-~~ \$24.75.

"SECTION FOUR"

This Ordinance and the increased sewer rates fixed, established and so duly ordained therein and thereby shall be effective as of the 1st day of April, 1990, and be applied to customers' sanitary sewer bills and statements for the billing period beginning 1 May 1990, all in accordance with the now present practices and methods utilized by the City of Dry Ridge in calculating and computing such sanitary sewer service charges.
