

ORDINANCE NO. 176

AN ORDINANCE FIXING THE TIMES AND DATES FOR THE REGULAR MEETINGS OF THE CITY COUNCIL OF THE CITY OF DRY RIDGE, KENTUCKY, AND FOR HIRING CERTAIN CITY EMPLOYEES AND FIXING THEIR COMPENSATION.

WHEREAS the City of Dry Ridge, Kentucky, of the 5th class is required by law to fix its meeting date and to hire certain employees and fix their compensation by ordinances.

NOW THEREFORE THE CITY COUNCIL OF THE CITY OF DRY RIDGE, KENTUCKY, DOES ORDAIN AS FOLLOWS:

SECTION I. It is hereby ordered and directed that the regular meeting of the City Council of the City of Dry Ridge, Kentucky, be held on the 1st Tuesday of each month at 8:00 P. M. E. S. T., in the City Building located on Broadway Street in said city.

SECTION II. It is hereby ordered and directed that Donald Pat Curry and Everett Lyon be, and they are hereby employed as City Policeman for the City of Dry Ridge, Kentucky, and their compensation is hereby fixed at \$90.00 per month each. Donald Pat Curry is to be Chief of Police.

SECTION III. It is hereby ordered and directed that Raymond R. Vincent, be, and he is hereby employed as City Attorney for the City of Dry Ridge, Kentucky, on the same terms and conditions and the same rate and method of pay as heretofore.

SECTION IV. It is hereby ordered and directed that H. C. Rohrs be, and he is hereby employed as City Clerk and City Treasurer for the City of Dry Ridge, Kentucky, and his compensation shall be as follows: \$30.00 per month; same to be retroactive to January 1, 1957; the said H. C. Rohrs is also to be building inspector to inspect all buildings and sewage disposal systems as per the building ordinances heretofore passed by said city and he shall receive the same fees as set up for said building inspections in those ordinances. The said H. C. Rohrs is also hereby employed as City Tax Assessor and Tax Collector and is to receive for such services a sum equal to 5% of all taxes collected by him and paid into the City Treasury. The Clerk fees for issuing licenses or permits are to be raised to \$1.00 for each license or permit issued and the said city Clerk shall receive those fees as a part of his compensation. It is hereby ordered and directed that in the event the salary and fees do not equal the sum of \$1000.00 annually then the City is to make up any difference between the amount actually received and the sum of \$1000.00 and said city hereby guarantees that the said H. C. Rohrs shall receive the sum of \$1000.00 for his services as Clerk and Treasurer of said city. It is further hereby ordered and directed that in the event the Clerks salary, commissions and fees exceed the

sum of \$1000.00 annually that same shall be retained by the said city Clerk and deemed to be compensation for his services.

SECTION V. If any section, clause or paragraph of this ordinance be held to be invalid such invalidity shall not affect the remaining sections, clauses or paragraphs; it being hereby expressly declared that same would have been passed despite such invalidity.

SECTION VI. All ordinances or parts thereof in conflict herewith are to the extent of such conflict hereby repealed.

SECTION VII. This ordinance shall be in full force and effect from and after its passage and publication as required by law.
