

ORDINANCE No. 178.

AN ORDINANCE AMENDING AND CORRECTING ORDINANCE NO. 149 HERETOFORE PASSED AND WHICH IMPOSES A LICENSE TAX UPON CERTAIN BUSINESSES, OCCUPATIONS, TRADES AND PROFESSIONS CARRIED ON, CONDUCTED, TRANSACTED, LOCATED OR HELD WITHIN THE CORPORATE LIMITS OF THE CITY OF DRY RIDGE, KENTUCKY, AND REQUIRING ALL PERSONS, FIRMS, CORPORATIONS, PARTNERSHIPS AND OTHER FORMS OF DOING BUSINESS PURSUING SAME TO FIRST OBTAIN A LICENSE THEREFOR AND PROVIDING PENALTIES FOR ENGAGING IN ANY SUCH BUSINESS, OCCUPATION, TRADE OR PROFESSION, WITHOUT HAVING SUCH A LICENSE.

WHEREAS it has been determined that certain portions of Ordinance No. 149 heretofore passed by the City of Dry Ridge, Kentucky, needs amending and correcting.

NOW THEREFORE THE CITY COUNCIL OF THE CITY OF DRY RIDGE, KENTUCKY, DOES ORDAIN AS FOLLOWS:

SECTION I. That Ordinance No. 149 be, and the same is, hereby amended and corrected in the following manner, to-wit:

SECTION II. Sub-Section E, Sub-Head 2 of Ordinance No. 149 is hereby amended and corrected to read as follows, to-wit:

"Electric shop for sale of television sets, radios, refrigerators, washing machines and all other appliances per year \$5.00 or picking up or delivering said items in this City per year \$5.00.

SECTION III Sub-Section P, Sub-Head 4 of Ordinance No 149 is hereby amended or corrected as follows, to-wit:

"Building contractors, contractors or sub-contractors, electrical contractors, heating contractors and plumbing contractors, shall pay an annual license tax of \$10.00 per year and such persons shall have the privilege of having one helper on each job for this fee. However if more than one helper is on any job then the said contractor shall pay an annual license tax of \$5.00 for each helper that he has over one.

Funeral directors and/or embalmers shall pay an annual license tax of \$10.00 per year and for this tax have the privilege of having one embalmer besides himself, for each additional embalmer he shall pay an additional license tax of \$5.00 for each embalmer over one.

Each physician shall pay a license tax of \$10.00 per year and this shall entitle him to have one helper, assistant or nurse at no additional charge; however for each assistant, helper or nurse over

over one he shall pay an additional license tax of \$5.00 per year.

SECTION IV. There shall be taxed as costs for every license issued by reason of this ordinance, the sum of \$1.00 which shall be paid the City Clerk by the one purchasing such license at the time such license is issued, and no license herein shall be issued until such costs have been paid to the clerk of the City of Dry Ridge, Kentucky, and receipted for by him, and such costs will inure to the Clerk of the City of Dry Ridge, Kentucky, as compensation for services rendered in issuing such license.

SECTION V. All ordinances, resolutions or parts thereof in conflict herewith are to the extent of such conflict hereby repealed.

SECTION VI. If an section, paragraph or clause of this ordinance be declared to be invalid such invalidity shall not affect the remaining sections, paragraphs or clauses; it being hereby expressly declared that same would have been passed despite such invalidity.

SECTION VII. This ordinance shall be in full force and effect from and after its publication as required by law.
