AN ORDINANCE AMENDING AND CORPECTING ORDINANCE NO. 178 HERETOFORE PASSED WHICH IS AN ORDINANCE AMENDING AND CORRECTING ORDINANCE NO. 149 HERE-TOFORE PASSED AND WHICH IMPOSES A LICENSE TAX UPON CERTAIN BUSINESSES, OCCUPATIONS, TRADES AND PROFESSIONS CARRIED ON, CONDUCTED, TRANSACTED, LOCATED OR HELD WITHIN THE CORPORATE LIMITS OF THE CITY OF DRY RIDGE, KENTUCKY, AND REQUIRING ALL PERSONS, FIRMS, CORPORATIONS, PARTNERSHIPS AND OTHER FORMS OF DOING BUSINESS PUBSUING SAME TO FIRST OTTAIN A LICENSE THEREFOR AND PROVIDING PENALTIES FOR ENGAGING IN ANY SUCH BUSINESS, OCCUPATIONS, TRADES OR PROFESSION WITHOUT HAVING SUCH A LICENSE.

WHEREAS it has been determined that a certain portion of Ordinance No. 178, heretofore passed by the City of Dry Ridge, Kentucky, needs amending and correcting.

NOW THEREFORE THE CITY C UNCIL OF THE CITY OF DRY RIDGE, KENTUCKU, DOES ORDAIN AS FOLLWS:

SECTION I. That Ordinance No. 178, be, and the same is, hereby amended, and corrected in the following manner to-wit:

SECTION II. Section III of Ordinance No. 178 is hereby amended and corrected so that same shall now read as follows to wit:

Building contractors, contractors or sub-contractors, electrical contractors, heating contractors and plumbing contractors shall be an annual license tax of \$10.00 per year and such persons shall have the privilege of having one helper on each job for this fee.

Funeral directors and/or embalmers shall pay an annual license tax o \$10.00 per year and for this tax have the privilege of having one embalmer besides himself, for each additional embalmer

he shall pay an additiona license tax of \$5.00 for each embalmer over one.

SECTION III. All ordinance, resolutions or parts thereof in conflict herewith are to the extent of such conflict hereby repealed.

SECTION IV. If any section, paragraph or clause of this ordinance be declared to be invalid such invalidity shall not affect the remaining sections, paragraphs, or clauses; it being hereby expressly declared that same would have been passed despite invalidity.

SECTION V. This ordinance shall be in full force and effect from and after its publication as required by law.
