

AN ORDINANCE GRANTING AN EXCLUSIVE FRANCHISE FOR THE TERM OF ONE YEAR FOR THE RIGHT AND PRIVILEGE OF ENTERING IN AND UPON THE STREETS, ALLEYS, PUBLIC WAYS AND PLACES OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY FOR THE PURPOSE OF COLLECTING AND PICKING UP AND HAULING AWAY OF GARBAGE, TRASH, REFUSE, ETC. FOR THE PURPOSE OF HAULING SAID GARBAGE, TRASH AND REFUSE, ETC. FOR BUSINESS AND PRIVATE CUSTOMERS.

WHEREAS the City Council of the City of Dry Ridge, Kentucky has heretofore advertised in the Grant County News for bidders for a franchise to collect and pick up garbage, trash and refuse in the City of Dry Ridge, Kentucky and,

WHEREAS said bids have been received and opened, read and considered publicly at a meeting of said City Council.

NOW THEREFORE THE CITY COUNCIL OF THE CITY OF DRY RIDGE, KENTUCKY, DOES OR AIN AS FOLLOWS:

SECTION I. The City Council, after having considered all bids submitted to it for an exclusive one (1) year franchise for the privilege of collecting and picking up of garbage, trash and refuse in the City of Dry Ridge, Kentucky, hereby determines that the bid of W. Z. Rimer Dry Ridge, Kentucky is the lowest and best bid received; that said bid is hereby accepted.

SECTION II. That said bid is hereby incorporated by reference and made a part of this ordinance as though fully setout herein and the rates setout in said bid are the rates that the successful bidder has guaranteed for a period of one (1) year from the date of the final passage of this ordinance.

SECTION III. The said successful bidder, his successors or assigns, shall have the right to discontinue the said service for non-payment of bills when due or for the using of said service contrary to the laws of the Commonwealth of Kentucky or ordinances of the City of Dry Ridge, Kentucky.

SECTION IV. The successful bidder shall either, by insurance or bond, save and hold harmless at all times during the term of this franchise, the City of Dry Ridge, Kentucky from any and all liability incurred or caused by the operation of his said business under the terms of this franchise.

SECTION V. The successful bidder shall collect and pick up said garbage and refuse over the entire city at least once each week, and on the same day each week and shall haul all of said garbage and refuse away and dispose of same himself ~~at some place outside territorial limits of Grant County, Kentucky~~, and shall comply with any and all laws and regulations of the City of Dry Ridge, Kentucky, now existing or hereafter passed in regard to said service.

SECTION VI. The successful bidder, his successors or assigns, shall have the power and authority to go upon such streets, alleys, public ways and places of the City of Dry Ridge, Kentucky and to do all things necessary and proper for the purpose of picking up and removing the garbage, trash and refuse as provided for in the franchise herein granted.

CITY COUNCIL
SECTION VII. This ordinance and the bid or proposal accepted by the ~~City Council~~ under the provisions hereof, together with the resolution accepting the bid or proposal, shall be and constitute a contract between the City of Dry Ridge and the person, firm, or corporation to whom the franchise, rights and privileges herein provided for are awarded, and the said contract, rights and privileges shall inure to and be binding upon the successors and assigns of the successful bidder.

SECTION VIII. This ordinance shall take effect and be in force upon and after its passage and approval and publication as required by law.

SECTION IX: The above named successful bidder shall before commencing operations under this franchise give a bond with good surety to the City conditioned on the faithful performance of this franchise, said bond shall be in the sum of \$1500.00; this franchise shall not be effective until said bond is executed and approved by the City Council.
