ORDINANCE NO. 783-2014

AN ORDINANCE OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, FIXING AND ESTABLISHING THE DATES, TIME, AND PLACE FOR THE CITY'S REGULAR BUSINESS MEETING MONTHLY REQUIRED BY KRS 83A.130(11) AND, LIKEWISE, ESTABLISHING THE DUE DATE, TIME, AND PLACE OF AN ADDITIONAL AUXILIARY-ANCILLARY MEETING OF AND FOR THE DRY RIDGE CITY COUNCIL; AND REPEALING CITY OF DRY RIDGE ORDINANCE NO. 689-2006.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF DRY RIDGE, KENTUCKY, FOR AND ON BEHALF OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, AS FOLLOWS:

General Article One

That City of Dry Ridge Ordinance No. 689-2006, heretofore enacted, concerning monthly meetings statutory regular and auxiliary-ancillary of the City of Dry Ridge and the Dry Ridge City Council, be and the same is hereby repealed.

General Article Two

That the Regular Business Meeting required by KRS 83A.130(11) of and for the City Council of the City of Dry Ridge, Grant County, Kentucky, shall and is hereby fixed and set to be had on the first Monday of each calendar-month beginning at the hour of 6:00 p.m., prevailing time, at the Dry Ridge City Building, 31 Broadway, Dry Ridge, Grant County, Kentucky 41035.

General Article Three

That an Auxiliary-Ancillary Meeting, if required, for or by the City Council of the City of Dry Ridge, Grant County, Kentucky, whereat city matters and business regular, requisite, or necessary, including discussions general or in caucus or in the nature of caucus, may be addressed, considered, or ordained in due course, shall be had and the same is hereby fixed and set and to be had on the third Monday of each calendar-month beginning at the hour of 6:00 p.m., prevailing time, at the Dry Ridge City Building, 31 Broadway, Dry Ridge, Grant County, Kentucky 41035.

This ordinance shall become effective and be in full force and effect when the same is duly adopted, approved, ordained, ordered published, and published according to law.
