RESOLUTION NO. #1-2000

Whereas, the City of Dry Ridge, Kentucky, budgets monies annually for the construction and maintenance of roadways, streets and sidewalks within the city's limits;

Whereas, the City Council of the City of Dry Ridge, Kentucky, has heretofore determined that pedestrian sidewalks are needed along the westerly side of South Main Street (U.S. Highway 25) Business Boulevard to Arbors Drive, and from Brentwood Drive to the Food Lion, a distance linear of approximately 0.25 miles;

Whereas, the city has been advised by the Commonwealth of Kentucky, Transportation Cabinet, that state monies up to the sum and amount of \$7,500.00 will be made available to reimburse the City of Dry Ridge, Kentucky, for costs and expenses incurred to undertake a construction project to construct the above sidewalks along the westerly side of South Main Street (U.S. Highway 25);

Whereas, the City Council of the City of Dry Ridge, Kentucky, by action affirmative taken at its Regular Meeting held on July 10, 2000, agreed to undertake the herein, sidewalk construction project and use the Transportation Cabinets funds up to the sum and amount of \$7,500.00 to reimburse the city for the costs and expenses incurred in the construction of said sidewalks, all under agree-

ment between the City and the Transportation Cabinet under authorized signature of the Mayor of the City of Dry Ridge, Kentucky, for and on behalf of the City of Dry Ridge, Kentucky; and

Whereas, the City Council of the City of Dry Ridge, Kentucky, hereby provides and so RESOLVES as follows, to-wit:

1. That the said Honorable William Cull, the Mayor of the City of Dry Ridge, Kentucky, be and is hereby empowered and authorized for and on behalf of the City of Dry Ridge, Kentucky, to execute and agreement with the Commonwealth of Kentucky, Transportation Cabinet, concerning the construction of sidewalks, 4-feet in width, along the westerly side of South Main Street (U.S. Highway 25) from Business Boulevard to Arbors Drive, and from Brentwood Drive to the Food Lion entrance, a linear distance of approximately 0.25 miles, all for which the City will be reimbursed for costs and expenses for said project up to the sum and amount of \$7,500.00 from funds of the Transportation Cabinet.

2. That the City of Dry Ridge, Kentucky, shall undertake and complete the above project pursuant to the agreement of the CITY and the DEPARTMENT.
