
AUTHORIZING RESOLUTION OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, RELATING TO AND AUTHORIZING THE CITY'S PARTICIPATION IN THE KENTUCKY LAW ENFORCEMENT FOUNDATION PROGRAM FUND.

WHEREAS, the City of Dry Ridge, Grant County, Kentucky, a Kentucky city and municipal entity of the fifth-class has heretofore established and maintained a law enforcement and safety division/department known as the City of Dry Ridge Police Department which it has recently reestablished and re-instituted by actions official; and

WHEREAS, the City Council of the City of Dry Ridge, Grant County, Kentucky, or and on behalf of the City of Dry Ridge, Grant County, Kentucky, and the City's police department (The City of Dry Ridge Police Department) and its officers and personnel to make application for participation and due participation in the Kentucky Law Enforcement Foundation Program Fund Training Incentive Program under this action and due resolution.




RESOLUTION

Adopted this 12TH day of MARCH, 2007.




