

MUNICIPAL ORDER NO. 1994-002

CITY OF DRY RIDGE, KENTUCKY

A MUNICIPAL ORDER OF THE MAYOR AND CITY COUNCIL OF THE CITY OF DRY RIDGE, KENTUCKY, FOR AND ON BEHALF OF THE CITY OF DRY RIDGE, KENTUCKY, AND THE DRY RIDGE POLICE DEPARTMENT DULY ADOPTING AND ESTABLISHING HEREBY POLICE POLICIES AND PROCEDURES FOR THE DRY RIDGE POLICE DEPARTMENT AND ADOPTING AN OPERATIONS MANUAL SETTING FORTH SUCH ADOPTED POLICE POLICIES AND PROCEDURES AND FOR USE BY THE OFFICERS OF THE DRY RIDGE POLICE DEPARTMENT.

WHEREAS, the Mayor and City Council of the City of Dry Ridge, Kentucky, in concert joint, have determined that policies and procedures concerning the activities official of the City of Dry Ridge Police Department and the officers thereof must be duly adopted and established together with the due adoption of an operations manual setting forth such adopted policies and procedures for use by the officers of the Dry Ridge Police Department; and

WHEREAS, pursuant to the authority granted by KRS 83A.060(12), the Mayor and City Council of the City of Dry Ridge, Kentucky, in concert joint, have determined, by enactment of a Municipal Order, to adopt and establish policies and procedures concerning the activities official for the Dry Ridge Police Department and the officers thereof, and adopt an operations manual setting forth such adopted policies and procedures for the benefit and use by the officers of the Dry Ridge Police Department.

NOW, THEREFORE, pursuant to Motion, Second and Vote affirmative and in the majority of the Mayor and City Council of the City of Dry Ridge, Kentucky, made and had after due consideration and discussion at a Regular Meeting held on September 12, 1994, it is hereby ORDERED that those police policies and procedures set forth in and within that writing and document styled and known as the "CITY OF DRY RIDGE POLICE POLICIES AND PROCEDURES MANUAL" be and the same are hereby so duly adopted and establish-

ed as the policies and procedures for and concerning the activities official of the City of Dry Ridge Police Department and the officers and personnel thereof and so hereby adopting an operations manual as to such adopted policies and procedures for the use and benefit of the officers and personnel of the City of Dry Ridge Police Department, which policies and procedures and operations manual, may from time to time be duly amended and changed as required and which, initial and as hereby so adopted and established both by this Municipal Order consists of the following entries or inclusions, consisting of 97 typewritten pages, to-wit:
