## A MUNICIPAL RESOLUTION OF THE CITY OF DRY RIDGE, IN GRANT COUNTY, KENTUCKY, ADOPTING THE

## "FIRE DEPARTMENT, FIRE CHIEF VISA BUSINESS CREDIT CARD AUTHORIZATION W/ \$3000 LIMIT"
