# OROMANCE NUMBER 298-1977

AN ORDINANCE ADOPTING THE BUDGET FOR THE CITY OF DRY RIDGE, KENTUCKY FOR THE FISCAL YEAR 1977, AND MAKING THE ANNUAL APPROPRIATION IN ACCORDANCE THEREWITH

The Mayor of the City of Dry Ridge submitted to the City Council of said City at a regular continued meeting held on December 27, 1976, a proposed budget for the fiscal year 1977. The Council is of the opinion that such budget is sound.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DRY RIDGE, KENTUCKY.

#### SECTION I

That the budget for the fiscal year 1977, recommended by the Mayor, reviewed by the Finance Committee and submitted to the City Council on December 27, 1976, as aforesaid be and it is hereby approved, adopted and incorporated herein and made a part hereof and as hereinafter set forth.

#### SECTION II

That the anticipated revenues for such fiscal period listed therein be and they now are appropriated and apportioned to the various departments of the City, for general and special purposes, in order to meet and provide the expense thereof, in accordance with the schedule or budget set out in Section III hereof.
