

AN ORDINANCE RAISING THE SEWER RATES TO ALL CUSTOMERS IN DRY RIDGE, KENTUCKY AND REPEALING ORDINANCE NO. 365-1981 AND AMENDING SECTIONS 4(B)(1); 4(B)(2); AND 4(B)(3) OF ORDINANCE 291-1976.

WHEREAS, the sewer rates to the customers of Dry Ridge must yield a sufficient revenue to pay for the water consumed in the Dry Ridge sewer plant.

NOW THEREFORE BE IT ORDAINED BY THE CITY OF DRY RIDGE:

SECTION ONE

Ordinance Number 365-1981 is hereby repealed.

SECTION TWO

Section 4(B)(1) of Ordinance 219-1976 is amended as follows:

(1) Basic Monthly Rates

Basic monthly rates for sewer service shall be based insofar as possible upon the quantity of water supplied to the respective buildings or premises, as follows:

Number of Gallons of Water Consumption Per Month	Monthly Sewer Charge
First 2,000 gallons or less	\$3.60 <u>\$5.60</u> (Minimum Monthly Charge)
All over 2,000 gallons	\$1.80 <u>\$2.50</u> per 1,000 gallons

SECTION THREE

Section 4(B)(2) of Ordinance 219-1976 is amended as follows:

(2) Surcharge

In addition to the basic monthly rates set out above, each residential customer of the municipal sewer system shall be required to pay a surcharge in the amount of \$6.00 per month, and each commercial customer of the system shall be required to pay a surcharge in the amount of ~~\$12.00~~ \$13.15 per month. Also in addition to the foregoing charges Apartment owners shall pay TWO DOLLARS (\$2.00) per dwelling unit.

SECTION FOUR

Section 4(B)(3) of Ordinance 219-1976 is amended as follows:

(3) Minimum Sewer Rates and Charges.


The minimum monthly bill for sewer service, including surcharge, to residential customers shall be ~~\$9.60~~ \$11.60 and each such customer shall be entitled in each month to discharge water into the municipal sewer system based upon water usage of 2,000 gallons or less for such minimum sewer charge of ~~\$9.60~~ \$11.60; and the minimum monthly bill for sewer service, including surcharge to commercial customers shall be ~~\$15.60-~~ \$18.75, and each such customer shall be entitled in each month to discharge water into the municipal sewer system based upon water usage of 2,000 gallons or less for such minimum sewer charge of ~~\$15.60~~ \$18.75. Also as stated in Section 4(B)(2) in addition to the foregoing charges Apartment owners shall pay TWO DOLLARS (\$2.00) per dwelling unit.

SECTION FIVE

This Ordinance shall go into effect August 1, 1981.

First reading: July 1, 1981. Second reading: July 13, 1981.
