ORDINANCE NO. 382-1982

AN ORDINANCE PROHIBITING THE PARKING OR STANDING OF VEHICLES ON CERTAIN SECTIONS OF U.S. 25 AND ON KENTUCKY HIGHWAY ROUTE 22, KNOWN AS BROADWAY.

WHEREAS, the City has been requested by the proper officials of the Kentucky Department of Highways to eliminate parking on certain portions of Main Street and Broadway Street to improve the flow of traffic in the City, and

WHEREAS, this action is deemed necessary by this council in order to protect the health and welfare of its citizens.

NOW THEREFORE BE IT ORDAINED BY THE CITY OF DRY RIDGE

SECTION ONE

No owner or operator of any vehicle shall, at any time, permit same to be parked or left standing on Broadway Street, Kentucky Highway 22 (Taft Highway) from its intersection with U.S. 25 on both the West bound side and East bound side of Broadway and continuing from that intersection of U.S. 25 west bound for a distance of Seventy-five (75) feet.

SECTION TWO

No owner or operator of any vehicle shall, at any time, permit same to be parked or left standing on U.S. 25, known as South Main Street, from a point beginning Seventy-five (75) feet North of Walnut Street on the South bound side of U.S. 25 to the intersection with Walnut Street.

SECTION THREE

Any person, firm or corporation found guilty of violating the provisions of this Ordinance shall be fined Five Dollars (\$5.00) for each offense.

SECTION FOUR

All Ordinances, Resolutions, Orders or parts thereof in conflict herewith, or to the extent of such conflict, are hereby repealed.

SECTION FIVE

If any sentence, paragraph or clause of this Ordinance be held by a proper Court to be invalid, such invalidity shall not affect the remaining sections, paragraphs or clauses, it being hereby expressly declared that the remainder of said Ordinance would have been passed despite such invalidity.

No owner or operator of any vehicle shall, at any time, permit same to be parked or left standing on Broadway Sreet, Kentucky Highway 22 (Taft Highway) from its intersection with U.S. 25 on both the West bound side and East bound side of Broadway and continuing from that intersection of U.S. 25 west bound for a distance of Seventy-five (76) feet.

SECTION TWO No owner or operator of any vehicle shall, at any time, permit same to be parked or left standing on U.S. 25, known as South Main Street, from a point beginning Seventy-five (75) feet North of Walnut Street on the South bound side of U.S. 25 to the Intersection with Walnut Street.

SECTION THREE Any person, firm or corporation found guilty of violating the provisions of this Ordinance shall be fined Five Dollars (\$5.00) for each offense.

SECTION FOUR

All Ordinances, Resolutions, Orders or parts thereof in conflict herewith, or to the extent of such conflict, are hereby repealed.

SECTION FIVE If any sentence, paragraph or clause of this Ordinance be held by a proper Court to be invalid, such invalidity shall not affect the remaining sections, paragraphs, or clauses, it being hereby expressly declared that the remainder of said Ordinance would have been passed despite such invalidity.
