#### ORDINANCE NO. 482-1992

AN ORDINANCE OF THE CITY OF DRY RIDGE REGULATING THE USE OF THE CITY'S STREETS BY ESTABLISHING SPPED LIMITS FOR VEHICULAR TRAFFIC AND SOCESTABLISHING PARKING REGULATIONS REGARDING BOTH ON-STREET AND OFF-STREET PARKING AND ESTABLISHING FINES, PENALTIES, SANCTIONS AND REMEDIES FOR VIOLATIONS.

WHEREAS, the City of Dry Ridge maintaines streets, roadways and thoroughfares within the incorporated limits of the city, the use of which requires regulations duly established and ordained together with fines, penalties, sanctions and remedies for violations of such regulations to insure the effect use of such streets, roadways and thoroughfares and to provide for the safety and welfare of the public.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF DRY RIDGE AS FOLLOWS:

### Section One

Those Kentucky Revised Statutes germane and applicable to vehicular traffic and the operation of vehicles and the use of streets, roadways and highways by pedestrians are hereby adopted by the City of Dry Ridge and shall be duly enforced by the city.

# Section Two

Unless otherwise posted, the speed limit upon all streets, thoroughfares and road-ways within the incorporated limits of the City of Dry Ridge shall be twenty miles per hour (20 m.p.h.).

#### Section Three

- A. The parking or stopping of any motor vehicle, vehicle or other measns of method of conveyance shall be allowed only within those places, areas and spaces designated for parking or stopping and at the hours and times set, established or fixed for same.
- B. Parking, stopping or the use of any space or area designated for 'handicapped parking' along the city's streets, thoroughfares and roadways and elsewhere within the incorporated limits of the city, including all off-street places and areas so designated or dedicated for 'handicapped parking', shall be limited and restricted to persons and vehicles to and for whom a 'handicapped parking' permit, license or decal has been issued and which such permit, license or decal is conspicuously desplayed on any vehicle parked or stopped within any 'handicapped parking space or area'.
- C. Fines, penalties, sanctions and remedies for violations of these parking regulations are set forth in Section Four of this Ordinance.

### Section Four

- A. Any person who violates Section Three (A) shall be fined the sum of \$10.00 payable to the Dry Ridge City Clerk within five (5) working days from the date of issuance of the citation for such violation, Saturdays and Sundays excluded. If such fine be not so paid within the term stated herein, then such violation and citation may, at the election of the City of Dry Ridge, be prosecuted within the courts of this State.
- B. Any person who violates Section Three (B) shall be fined the sum of \$30.00 payable to the Dry Ridge City Clerk within five (5) working days from the date of issuance of the citation for such violation, Saturdays and Sundays excluded. If such fine be not so paid within the term stated herein, then such violation and citation may, at the election of the City of Dry Ridge, be prosecuted within the courts of this State.
- C. Any vehicle or other means or method of conveyance illegally parked or stopped may be removed or towed from such restricted or prohibited place or area with the owner or operator of such vehicle/means of conveyance being liable and responsible for the costs incurred for such removal and the storage of the illegally parked vehicle or other means of conveyance.

## Section Five

This ordinance shall become effective and be in force upon its due passage, ordination and publication according to law.
