AN ORDINANCE OF THE CITY OF DRY RIDGE, KENTUCKY, AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF DRY RIDGE CHANGING THE ZONING CLASSIFICATION OF A 0.620-ACRE PARCEL OF LAND LOCATED WITHIN THE CORPORATE LIMITS OF THE CITY OF DRY RIDGE, KENTUCKY, AND SITUATED ON THE SOUTHERLY SIDE OF WARSAW AVENUE OWNED BY CRANT COUNTY DRUGS, INC. FROM THE PROPERTY'S PRESENT ZONING CLASSIFICATION OF NEIGHBORHOOD COMMERCIAL (N-C) TO RESIDENTIAL FOUR (R-4) AND SO FURTHER CHANGING THE ZONING CLASSIFICATION OF A 0.609-ACRE PARCEL LOCATED WITHIN THE CORPORATE LIMITS OF THE CITY OF DRY RIDGE, KENTUCKY, AND SITUATED ON THE SOUTHERLY SIDE OF WARSAW AVENUE OWNED BY GRANT COUNTY DRUGS, INC. FORM THE PROPERTY'S PRESENT ZONING CLASSIFICATION OF NEIGHBORHOOD COMMERCIAL (N-C) TO RESIDENTIAL FOUR (R-4).

## BE IT ORDAINED BY THE CITY OF DRY RIDGE, KENTUCKY:

WHEREAS, on the 25th day of March, 1994, the Grant County Joint Planning Commission did hold a public hearing on the Application of Grant County Drugs, Inc. requesting a change in zoning classification and map amendment from City of Dry Ridge Neighborhood Commercial (N-C) to City of Dry Ridge Residential Residential Four (R-4) for a 0.620-acre parcel of land an a 0.609-acre parcel of land each located within the corporate limits of the City of Dry Ridge, Kentucky, and situated on the southerly side of Warsaw Avenue; and upon the foregoing Application, the Grant County Joint Planning Commission did make written findings of fact and conclusions of law in support of the requested zone changes and map amendments together with written recommendations addressed to and received by the City Council of the City of Dry Ridge, Kentucky, that Grant County Drugs, Inc.'s requested changes in zoning classification and zoning map amendments be granted, approved and duly so ordained by the City of Dry Ridge, Kentucky; and

WHEREAS, the City Council of the City of Dry Ridge, Kentucky, did at its Regular Meeting held on May 2, 1994, did review the written findings, conclusions and recommendations of the said Grant County Joint Planning Commission and did so concur in the findings, conclusions and recommendations of the Commission concerning the change in zoning classification and map amendment for the two parcels of real property on Warsaw Avenue from N-C to R-4 upon Vote sufficient, affirmative and in the majority upon Motion

made and timely Seconded with the Vote of the City Council of the City of Dry Ridge, Kentucky, being as follows:

## Parcel One:

Lying and being in Grant County, Kentucky, in the City of Dry Ridge, and on the South side of Warsaw Avenue and more particularly described as follows, to-wit: BEGINNING at a point in the center of Warsaw Avenue and a corner to John Skirvin; thence with center of said road, N 84° 20' E -- 128.6 feet to a point, a corner to Grant County Drugs; thence with said line, S 6° 15' to a point, a corner to Grant County Drugs; thence with said line, S 6° 15' line, S 83° 18' W -- 51.09 feet to an iron pipe, a corner to Freda Adams; thence with said line, S 86° 26' W -- 78.74 feet to an iron pin, a corner to John Skirvin; thence with said line, N 5° 56' W -- 207.52 feet to the place of beginning, containing 0.620 Acres, more or less, exclusive of all right-of-ways and easements of record.
