## ORDINANCE NO. 573-1998

AN ORDINANCE AMENDING ARTICLE VII, SECTION ONE OF CITY OF DRY RIDGE ORDINANCE NO. 354-1980 THEREBY ESTABLISHING NEW CONNECTION FEES AND CHARGES RELATING TO THE USE OF THE CITY'S MUNICIPAL SEWER SYSTEM.

## BE IT HEREBY ORDAINED BY THE CITY OF DRY RIDGE AS FOLLOWS:

## ARTICLE VII

Fees and Charges
Section One of Artice VII of City of Dry Ridge Ordinance No. 354-1980
is hereby amended as follows:

See= 1.---For-each-connection-to-the-public-sewer,-a-tap-in-fee-of-\$500.00 shall-be-paid-to-the-Gity-with-the-application-for-a-building-sewer-permit-In-addition-to-the-above-tap-in-fee,-persons-obtaining-an-Industrial-Waste-water-Discharge-Permit-shall-reimburse-the-Gity-for-the-actual-cost-of-all-testing-required-to-evaluate-the-industrial-effluent---

- Section 1. The following connection fees shall be charged for all connections made to the sanitary sewer system within the City of Dry Ridge, Kentucky, and it shall be the duty of the City to collect said fees.
- (1) Commercial establishments. The connection fee for each commercial establishment shall be ONE THOUSAND TWO HUNDRED FIFTY DOLLARS (\$1,250.00).
- (2) Industrial establishments. The connection fee for industrial establishment THOUSAND TWO shall be FIVE HUNDRED DOLLARS (\$2,500.00).
- (3) Residential establishments. The connection fee for residential establishments shall be as follows:
- (a) <u>Single-family residences and duplexes--- SIX HUNDRED TWENTY-FIVE DOLLARS</u> (\$625.00).
  - (b) Apartment buildings having 3 to 8 units---- ONE THOUSAND TWO HUNDRED FIFTY DOLLARS (\$1,250.00) per building.

- (c) Apartment buildings having 9 to 16 units--- ONE THOUSAND FIVE HUNDRED DOLLARS (\$1,500.00) per building.
- (d) Apartment building have 17 or more units--- ONE HUNDRED TWENTY-FIVE DOLLARS (\$125.00) per unit.
- Facilities for such Uses. The connection fee for such use-type or facility shall be NINE HUNDRED FIFTY DOLLARS (\$950.00) plus ONE HUNDRED DOLLARS (\$100.00) per each room made available for occupancy/use by customers or expected users of a hotel, motel or term-occupant, or patients of a hospital, normalized home or extended care facility or each room to be used as a class-room or restroom in an educational building or educational facility.
- has more than one permitted use, the greater or greatest fee hereunder for such permitted use shall be charged or levied for sewer connection.

The herein charges for sewer connection to the City of Dry Ridge's Municipal Sewer System shall become effective on February 1, 1998.
