AN ORDINANCE OF THE CITY OF DRY RIDGE, KENTUCKY, ESTABLISHING CERTAIN REQUIREMENTS UPON APPLICANTS FOR CITY ADMINISTRATIVE ACTIONS AND SETTING CERTAIN CHARGES TO BE PAID BY APPLICANTS TO DEFRAY OR COMPENSATE THE CITY FOR EXPENSES INCURRED BY IT FOR MANDATED PUBLICATION AND DOCUMENT AMENDING COSTS.

## BE IT HEREBY ORDAINED BY THE CITY OF DRY RIDGE AS FOLLOWS:

## SECTION ONE

That all applicants before the City of Dry Ridge requesting a zoning change/amendment to city zoning map official shall provide the city with (1) A surveyed and scaled map, plat or drawing of the parcel or property real to be rezoned; and (2) A surveyor's legal description of the parcel or property to be rezoned which matches the foregoing, scaled map, plat or drawing the the said parcel or property real.

## SECTION TWO

All applicants before the City of Dry Ridge receiving affirmative relief granting a zoning change/amendment to city zoning map official shall pay to the city the city's cost actual to make and effect an amendment to the city's Official Zoning Map which cost shall be not less than the sum and amount of One Hundred Twenty-Five Dollars (\$125.00).

## SECTION THREE

All applicants before the City of Dry Ridge requesting administrative actions requiring the publication of legal notice or publication of ordinance or documentation of action official, shall pay to the city the city's actual publication expenses or costs which cost shall be not less than the sum and amount of One Hundred Dollars (\$100.00).
