A JOINT ORDINANCE OF THE CITIES OF DRY RIDGE, KENTUCKY, AND WILLIAMSTOWN, KENTUCKY, CONFIRMING THE CITIES' SEWERAGE PRETREATMENT PROGRAM ADMINISTRATION AGREEMENT OF MAY 3, 1999, REGARDING THE CITY OF DRY RIDGE'S SEWERAGE PRETREATMENT PLAN PROGRAM CONCERNING THE CITY OF DRY RIDGE'S "INDUSTRIAL" AND OTHER USERS/CONTRIBUTORS OF WASTEWATER EFFLUENT TO THE CITY OF DRY RIDGE'S MUNICIPAL SEWER SYSTEM; ACKNOWLEDGING THE CITY DRY RIDGE'S DELEGATION OF ADMINISTRATIVE AND ENFORCEMENT POWERS AND DUTIES REGARDING AND CONCERNING THE CITY OF DRY RIDGE'S SEWERAGE PRETREATMENT PLAN AND PROGRAM TO AND UNTO THE CITY OF WILLIAMSTOWN, KENTUCKY, UNDER AND PURSUANT TO PRETREATMENT PROGRAM ADMINISTRATION AFORESAID SEWERAGE INTERLOCAL/MULTIJURISDICTIONAL AGREEMENT; ACKNOWLEDGMENT THE CITY OF WILLIAMSTOWN, KENTUCKY, OF THE CITY OF DRY RIDGE'S DELEGATION OF POWERS AND DUTIES TO THE CITY OF WILLIAMSTOWN FOR THE ADMINISTRATION AND ENFORCEMENT OF THE CITY OF DRY RIDGE'S SEWERAGE PRETREATMENT PLAN AND PROGRAM, AND THE CTTYWILLLIAMSTOWN'S DUE ACCEPTANCE OF THIS DELEGATION OF DUTIES THE CITY OF DRY RIDGE'S SEWERAGE REGARDING POWERS PRETREATMENT PLAN AND PROGRAM; AND THE DUE AUTHORIZATION AND GRANT OF THE CITY OF DRY RIDGE, KENTUCKY, TO AND UNTO THE CITY OF WILLIAMSTOWN, KENTUCKY, ITS EMPLOYEES, PERSONNEL AGENTS AND ASSIGNS, WITH THE POWER AND AUTHORITY TO ENTER INTO THE CORPORATE LIMITS OF THE CITY OF DRY RIDGE, KENTUCKY, TO ADMINISTER AND ENFORCE THE TERMS, CONDITIONS AND COMPLIANCE OF THE CITY OF DRY RIDGE'S SEWERAGE PRETREATMENT PLAN AND PROGRAM.

WHEREAS, the City of Williamstown, Kentucky, owns and operates a municipal sewer system and a wastewater treatment plant and system;

WHEREAS, the City of Dry Ridge, Kentucky, owns and operates municipal sewer system collecting the users' wastewater effluent which is transported to and treated by the City of Williamstown's wastewater treatment plant and system;

WHEREAS, the cities of Williamstown and Dry Ridge have heretofore, pursuant to state and federal laws and regulations, duly adopted and enacted sewerage pretreament plans and programs covering industrial or other categorized users contributing wastewater and sewerage effluent into the cities sewer systems;

WHEREAS, the cities of Dry Ridge and Williamstown have under date of May 3, 1999, entered into a Sewerage Pretreatment Program Administration Agreement, all pre-approved by the Commonwealth of Kentucky, Department For Enviornmental Protection, and authorized by Resolutions separate of the cities of Dry Ridge and Williamstown under date of May 3, 1999, concerning and regarding the sewerage pretreatment plan and program of the City of Dry Ridge, Kentucky;

WHEREAS, under the hereinabove sewerage pretreatment plan and program of the City of Dry Ridge, Kentucky, and the cities' interlocal agreement of May 3, 1999, the power and authority to administer and enforce the City of Dry Ridge's sewerage pretreatment plan and program has been delegated by the City of Dry Ridge, Kentucky, to and unto the City of Williamstown, Kentucky; and

WHEREAS, the City Councils of the City of Dry Ridge, Kentucky, and the City of Williamstown, Kentucky, hereby, jointly and severally, by this ordinance, desire to enact provisions necessary to the implementation and enforcement of the cities' interlocal agreement, and to empower and authorize the City of Williamstown, Kentucky, to transact within the corporate limits of the City of Dry Ridge, Kentucky, concerning the cities' interlocal agreement and regarding the administration and due enforcement of the City of Dry Ridge's Sewerage Pretreatment Plan and Program.

BE IT HEREBY ORDAINED BY THE CITY OF DRY RIDGE, KENTUCKY, AND THE CITY OF WILLIAMSTOWN, KENTUCKY, JOINTLY AND SEVERALLY, FOR AND ON BEHALF OF THE CITIES OF DRY RIDGE AND WILLIAMSTOWN, AS FOLLOWS:

## Article One

The cities' interlocal/multijurisdictional agreement of May 3, 1999, styled: "Pretreatment Program Administration Agreement", concerning the due administration and enforcement of the City of Dry Ridge's Sewerage Pretreatment Plan and Program covering industrial and other categorized user/contributors of wastewater effluent to the City of Dry Ridge's Municipal Sewer System, be and the same is hereby affirmed and confirmed.

## Article Two

The City of Dry Ridge and the City of Williamstown hereby acknowledge the City of Dry Ridge's due delegation of the duty of administration and delegation of the power of enforcement to and unto the City of Williamstown concerning the administration and enforcement of the City of Dry Ridge's Sewerage Pretreatment Plan and Program, under and pursuant to the cities' interlocal/multijurisdictional agreement of May 3, 1999.

## Article Three

The City of Williamstown, Kentucky, hereby duly accepts the City of Dry Ridge's delegation of administrative duties and delegation of enforcement powers concerning the City of Dry Ridge's Sewerage Pretreatment Plan and Program, under and pursuant to the cities' interlocal/multijurisdictional agreement of May 3, 1999.

## Article Four

The City of Dry Ridge, Kentucky, hereby authorizes and grants to and unto the City of Williamstown, Kentucky, its employees, personnel, agents and assigns the power and authority to enter into the corporate limits of the City of Dry Ridge, Kentucky, to transact and undertake all acts and actions necessary to administer and enforce the City of Dry Ridge's Sewerage Pretreatment Plan and Program, to the completion and pursuant to the cities' interlocal/multijurisdictional agreement of May 3, 1999.
