

ORDINANCE NO. 608-2000

AN ORDINANCE OF THE CITY OF DRY RIDGE, KENTUCKY, PROVIDING FOR THE CONSOLIDATION OF THE LAW ENFORCEMENT FUNCTIONS OF THE CITY UNDER AND PURSUANT TO AND INTER-GOVERNMENTAL AGREEMENT WITH THE COUNTY OF GRANT, KENTUCKY, UNDER THE AUTHORITY OF THE INTERLOCAL COOPERATION ACT (KRS 65.210, et seq.) TO AND WITHIN THE COUNTY OF GRANT, KENTUCKY; ADOPTING, APPROVING, CONFIRMING AND ORDAINING THAT INTER-GOVERNMENTAL AGREEMENT BY AND BETWEEN THE CITY OF DRY RIDGE, KENTUCKY AND THE COUNTY OF GRANT, KENTUCKY, SO ESTABLISHING AND EFFECTING THE DUE CONSOLIDATION OF LAW ENFORCEMENT FUNCTIONS IN, WITH AND TO THE COUNTY OF GRANT, KENTUCKY; AND AUTHORIZING THE MAYOR OF THE CITY OF DRY RIDGE, KENTUCKY, FOR AND ON BEHALF OF THE CITY OF DRY RIDGE, KENTUCKY, TO MAKE AND EXECUTE THE SAID INTER-GOVERNMENTAL AGREEMENT TOGETHER WITH ALL ATTACHMENTS, EXHIBITS, SCHEDULES, AND ADDENDA THERETO, AND TO EXECUTE AND DELIVER ALL DOCUMENTS, PAPERS AND ITEMS OF PROPERTY NECESSARY TO COMPLETE THE INTENT, PROVISIONS, PERFORMANCE AND DUE ADMINISTRATION OF THE SAID INTER-GOVERNMENTAL AGREEMENT CONCERNING THE CONSOLIDATION OF LAW ENFORCEMENT FUNCTIONS.

BE IT HEREBY ORDAINED BY THE CITY OF DRY RIDGE, KENTUCKY AS FOLLOWS:

Whereas, the City of Dry Ridge, Kentucky is a Kentucky city of the 5th class exercising police powers and providing various municipal services to its residents, citizens and others, including policing and law enforcement services through its present police department;

Whereas, the city desires to continue such policing and law enforcement services, but under a less costly and more efficient mode by consolidation of law enforcement functions with and into the County of Grant, Kentucky;

Whereas, the said County of Grant, Kentucky, has indicated its willingness to enter into a joint and cooperative agreement with the City of Dry Ridge, Kentucky, to consolidate law enforcement functions of the party entities and local governmental units to make the most efficient use of said entities' resources and enabling each to cooperate on the basis of mutual advantage;

Whereas, the City of Dry Ridge and the County of Grant desire to enter into an Inter-Governmental Agreement pursuant to the authority of the Interlocal Cooperation Act (KRS 65.210, et seq.) to effect a consolidation of law enforcement functions to the same's mutual advantage and effective use of resources; and

Whereas, to effect and carry out the foregoing, the City of Dry Ridge, Kentucky, so provides and duly ordains as follows, all for the use, benefit, protection and welfare of the citizens and residents of the City of Dry Ridge, Kentucky.

SECTION ONE

Effective on July 1, 2000, the law enforcement functions of the City of Dry Ridge, Kentucky, be and the same are hereby consolidated to, with, and within the County of Grant, Kentucky, pursuant to and under the provisions of that inter-governmental agreement referred to hereinafter.

SECTION TWO

In order to effect a consolidation of its law enforcement functions, the City of Dry Ridge, Kentucky, be and the same is empowered and authorized, pursuant to and under the authority of the ~~Interlocal Cooperation Act (KRS 65.210, et seq.)~~, to enter into an inter-governmental agreement with the County of Grant, Kentucky, to become effective on July 1, 2000.

SECTION THREE

The Mayor of the City of Dry Ridge, Kentucky, be and he is hereby authorized and empowered for and on behalf of the City of Dry Ridge, Kentucky, to make and execute the said inter-governmental agreement referred to within Section Two above together with all attachments, exhibits, schedules, and addenda thereto; and to execute and deliver all documents, papers and items of property necessary to complete the intent, provisions, performance and due administration of the said inter-governmental agreement concerning the consolidation of law enforcement functions.

SECTION FOUR

That Inter-Governmental Agreement concerning a consolidation of law enforcement functions together with all attachments, exhibits, schedules, and addend thereto, to be effective on July 1, 2000, so made and entered into by and between the County of Grant, Kentucky, and the City of Dry Ridge, Kentucky, be and the same is hereby ratified, accepted, adopted, approved and hereby ordained as contract of and for the benefit of the City of Dry Ridge, Kentucky.

SECTION FIVE

The provisions of this ordinance are severable; and the invalidity of any provision of this ordinance shall not affect the validity of any other provision thereof; and such other provisions shall remain in full force and effect as long as they remain in the absence of those provisions determined to be invalid.

SECTION SIX

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

SECTION SEVEN

This ordinance shall become effective as soon as the same is ordained and published according to law with the agreement duly approved by the Kentucky Attorney General.
