

ORDINANCE NO. 623-2001

AN ORDINANCE OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, ESTABLISHING, FIXING AND SETTING THE COSTS, CHARGES, RATES, TERMS, CONDITIONS AND PREREQUISITES FOR THE USE OF THE CITY'S EMPLOYEES, PERSONNEL, EQUIPMENT OR MATERIALS.

WHEREAS, there may exist times and occasions when the city may elect to use its employees, personnel, property, equipment or materials to perform work required by statute or ordinance for which persons or property benefiting from the labor, property, equipment or materials required or provided by the city shall bear the cost of same and be required to pay and reimburse the city the costs and expenses incurred by it; and, further, there may exist times and occasions when the city may elect at its option alone to allow persons or entities within the city's limits to use the city's employees, personnel, equipment or materials for which such persons or entities shall be required to reimburse the city for same; and

WHEREAS, the City Council of the City of Dry Ridge hereby intends to establish, fix and set the costs, charges, rates, terms, conditions and prerequisites for the providing or use of the city's employees, personnel, equipment or materials.

BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF DRY RIDGE, KENTUCKY, FOR THE CITY OF DRY RIDGE, KENTUCKY, AS FOLLOWS, TO-WIT:

Section One

The providing or use of the city's employees, personnel, equipment or materials pursuant to this ordinance shall not be allowed or commenced without (1) prior written application to the Mayor to allow the city's use of its employees, personnel, equipment or materials and a clear statement setting forth the nature or the work to be performed and the duration of same; and (2) the Mayor's confirmation and approval of the foregoing written request and his approval thereof. Further, the Mayor in his or her discretion may decide and elect not to allow the application and request unless such labor, work, equipment or materials is required by statute or ordinance and been previously approved and ordered by the Dry Ridge City Council.

Section Two

A. All non-city work agreed or permitted pursuant hereto shall be supervised by personnel of the city.

B. All property or equipment let or provided pursuant hereto shall be used or operated by employees or personnel of the city only.

C. All rates, costs, charges and expenses hereunder computed for labor shall be portal to portal and include time necessary for loading, delivery, setup, take-down, return to city facilities and replacement of equipment at the end of the work day.

Section Three

A. All labor costs and charges computed for the use of city employees and personnel shall be in units and increments of not less than one, quarter-hour.

B. The rates, charges or costs for city employees and personnel is as follows: (1) Supervisory or supervisory-level personnel... \$20.00/hour; (2) Nonsupervisory personnel or nonsupervisory-level personnel... \$18.00/hour; and (3) Inmates on supervised work-release... \$10.00 for lunch.

Section Four

Unless otherwise provide, the rates, charges and costs for providing or using the city's property, tools, equipment or materials shall be for a minimum of 4-hours use and are as follows: (1) Non-powered tools manual or hand... \$12.00/hour; (2) Powered tools and equipment operated by hand or operator... \$35.00/hour; (3) Generators or compressors... \$25.00/hour; (4) Loaders... \$50.00/hour; (5) Trucks... \$40.00/hour; (6) Salt-spreading/Snow-removal equipment... \$75.00/hour; and (7) Roadway barricades and street plates... \$10.00/day each with a minimum of one day's use (8 hours).
