

**ORDINANCE NO. 689-2006**

**AN ORDINANCE OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, FIXING AND ESTABLISHING THE DATES, TIMES, AND PLACE FOR REGULAR BUSINESS AND REGULAR CAUCUS MEETINGS OF THE DRY RIDGE CITY COUNCIL.**

**WHEREAS**, now the City Council of the City of Dry Ridge, Grant County, Kentucky, has a single Regular Meeting of City Council fixed by ordinance whereat it considers matters coming before the City for considerations and actions official;

**WHEREAS**, the City Council of the City of Dry Ridge, Kentucky, has determined that due to increased and increasing activities and matters concerning the City there exists a need for an additional forum whereby and whereat matters of concern and germane to the City can be informally, in caucus, prior to coming before Council for considerations and actions official; and

**WHEREAS**, the City Council of the City of Dry Ridge, Grant County, Kentucky, by this standing Ordinance, hereby, for and on behalf of the City of Dry Ridge, Grant County, Kentucky, establishes, fixes, and sets the place, dates and times for the city's Regular Business Meeting and the city's Regular Caucus Meeting.

**NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF DRY RIDGE FOR AND ON BEHALF OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, AS FOLLOWS:**

**GENERAL ARTICLE**

1. That the Regular Business Meeting for the City Council of the City of Dry Ridge, Grant County, Kentucky, shall and is hereby fixed and set to be had on the first Monday of each calendar-month beginning at the hour of 7:00 p.m., prevailing time, at the Dry Ridge City Building, 31 Broadway, Dry Ridge, Grant County, Kentucky 41035.

2. That the Regular Caucus Meeting for the City Council of the City of Dry Ridge, Grant County, Kentucky, shall and is hereby fixed and set to be had on the third Monday of each calendar-month beginning at the hour of 5:30 p.m., prevailing time, at the Dry Ridge City Building, 31 Broadway, Dry Ridge, Grant County, Kentucky 41035.

This ordinance shall become effective and be in full force and effect when the same is duly adopted, approved, ordained, ordered published, and published according to law.
