

**ORDINANCE NO. 711-2007**

AN ORDINANCE OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, UNDER THE AUTHORITY OF KRS 83A.130(5) PROVIDING FOR THE MANNER IN AND BY WHICH A MEMBER OF CITY COUNCIL MAY BE SELECTED BY CITY COUNCIL TO PRESIDE AT MEETINGS OF CITY COUNCIL IN PLACE OF THE MAYOR.

**WHEREAS**, the City of Dry Ridge, Grant County, Kentucky, is a Kentucky municipal entity and city of the 5th-class organized under a mayor-council plan and form of governmental operation as provided for by KRS 83A.130 which transacts the business and matters of the city at meetings of record official whether standing, regular or special;

**WHEREAS**, the City Council of the City of Dry Ridge, Kentucky, has determined that from time to time there may exist situations where the Mayor of the City of Dry Ridge, Kentucky, cannot attend and preside at meetings of City Council, or should not preside at meetings of City Council; and

**WHEREAS**, the City Council of the City of Dry Ridge, Kentucky, hereby and hereunder intends to promulgate the procedures of manner, pursuant to KRS 83A.130 (5) by which a member of City Council may be selected by the members of City Council to preside at meetings of City Council in place of the Mayor.

**NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE CITY OF DRY RIDGE, KENTUCKY, AS FOLLOWS;**

**GENERAL ARTICLE**

Pursuant to the authority of KRS 83A.130 (5), the manner by which a member of the Dry Ridge City Council may be selected by the members of City Council to preside at meetings of City Council in place of the Mayor shall be as follows, to-wit:

(1) At the commencement of a meeting official, the reasons and grounds specific regarding why a councilperson needs to preside and the meeting in the Mayor's stead shall be proved and placed of record.

(2) The name of a councilperson, under due second, shall be placed in nomination as meeting presider and whom must be then elected as meeting presider by a vote affirmative and in the majority if the entire membership of Council.

(3) Upon due election as provided above, the councilperson-presider may chair and conduct the meeting's agenda and business in accordance with KRS 83A.130 (5).

This ordinance shall become operable and be in full force and effect when passed, ordained, approved, ordered published and published according to law.
