AN ORDINANCE OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, CONCERNING AND RELATING TO THE CITY'S ESTABLISHMENT AND RE-ESTABLISHMENT OF A POLICE DEPARTMENT WITH OFFICERS AND PERSONNEL THEREOF FOR THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY.

WHEREAS, the City of Dry Ridge, Grant County, Kentucky, a Kentucky city and municipal entity of the fifth-class did heretofore establish and maintain a law enforcement and safety division/department complete with officers and personnel known as the City of Dry Ridge Police Department which was suspended while the city under an interlocal agreement had law enforcement services provided by the officers and personnel of the Grant County Kentucky Sheriff's Department which agreement and activity has been canceled necessitating the due establishment and re-establishment of the city's police department; and

WHEREAS, the City Council of the City of Dry Ridge, Grant County, Kentucky, for and on behalf of the City of Dry Ridge, Grant County, Kentucky, hereunder and by these present intends to ordain, establish, and re-establish a police department with officers and personnel for the said City of Dry Ridge, Grant County, Kentucky.

BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, AS FOLLOWS:

GENERAL ARTICLE

- (1) There is hereby duly ordained and established and re-established for the City of Dry Ridge, Grant County, Kentucky, a city safety division/department complete with officers and personnel of the said city being and to be known as The City of Dry Ridge Police Department.
- (2) That the officers and personnel of the said Dry Ridge Police Department shall be as heretofore provided and ordained in and within the City of Dry Ridge's Personnel Policies and Procedures at Position Descriptions, Pages 99 through 236, duly enacted and ordained October to November of 2007; and be duly classified and compensated as to grade as set forth and provided for in and within the City of Dry Ridge's Classification and Compensation Plan under Authorized Classes duly enacted, resolved and/or ordained October to November of 2007.
