

ORDINANCE NO. 776-2013

AN ORDINANCE OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, AFFIRMING, READOPTING AND RE-ORDAINING CITY OF DRY RIDGE ORDINANCES NO. 604-2000, NO. 710-2007 AND NO. 730-2008 REGARDING AND CONCERNING THE LEVYING OF AN OCCUPATIONAL LICENSING FEE UPON EMPLOYEES FOR THE PRIVILEGE OF ENGAGING IN WORK ACTIVITIES WITHIN THE CITY OF DRY RIDGE, KENTUCKY; AND ALSO AMENDING THE OCCUPATIONAL LICENSING FEE ORDINANCE INITIAL, NO. 604-2000, AT SECTIONS THREE AND FIVE THEREOF, RESPECTIVELY, TO PROVIDE FOR AMENDMENTS THERETO REFLECTING AN INCREASE OF THE EMPLOYEE-LICENSING FEE AND A NEW, EFFECTIVE DATE OF THE SAID INCREASED FEE LEVY SO DULY ADOPTED AND ENACTED PURSUANT TO AND UNDER THE AUTHORITY OF SECTION 181 OF THE CONSTITUTION OF THE COMMONWEALTH OF KENTUCKY, AND KRS 92.280(2), AND THE PROVISIONS APPLICABLE OF KRS 67.750 TO AND THROUGH KRS 67.795, ALL FOR THE HEALTH, SAFETY, WELFARE AND CONVENIENCE OF THE INHABITANTS, RESIDENTS AND CITIZENS OF THE CITY OF DRY RIDGE, KENTUCKY.

BE IT HEREBY ORDAINED BY THE CITY OF DRY RIDGE, KENTUCKY, AS FOLLOWS:

GENERAL ARTICLE ONE

(1) City of Dry Ridge Ordinance No. 604-2000 concerning the establishment and levy of an occupational license fee on employees for the privilege of engaging in work activities within the City of Dry Ridge as heretofore ordained and becoming operative on May 1, 2000, together with City of Dry Ridge Ordinance No. 710-2007 enacted on April 2, 2007, and Ordinance No. 730-2008 enacted on July 7, 2008, be and the same are each hereby duly reaffirmed, readopted and re-ordained save as hereby amended.

(2) That City of Dry Ridge Ordinance No. 604-2000 concerning employee occupational licensing fees as heretofore adopted and ordained and herein above reaffirmed, be and the same is hereby amended as follows, to-wit:

"SECTION THREE"

Effective date of ordinance...

The requirement of an employee occupational license and the imposition of an occupational licensing fee upon employees, as established and fixed hereinafter, shall be effective as of ~~May 1, 2000~~ October 1, 2013.

"SECTION FIVE"

Levy of employee occupational licensing fees...

For the privilege of being employed or engaged in any occupation, business, trade, profession, or other activity within the City of Dry Ridge as an employee, the employee shall pay an occupational licensing fee of ~~one-half percent (1/2%)~~ one percent (1.00%) of all wages, salaries, commissions, or other compensation earned by such employee in the city for work done or services performed or rendered within the City of Dry Ridge, Kentucky.

GENERAL ARTICLE TWO

Severability...

Each section and each provision of each section of this ordinance are severable; and if any provision, section, paragraph, sentence or part thereof, or the application thereof to any person, licensee, class or group, is held by a court of law to be unconstitutional or invalid for any reason, such holding shall not affect or impair the remainder of this ordinance, it being the legislative intent to ordain and enact each provision, section, paragraph, sentence and part thereof, separately and independently of the rest.

AN ORDINANCE OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, AFFIRMING, READOPTING AND RE-ORDAINING CITY OF DRY RIDGE ORDINANCES NO. 604-2000, NO. 710-2007 AND NO. 730-2008 REGARDING AND CONCERNING THE LEVYING OF AN OCCUPATIONAL LICENSING FEE UPON EMPLOYEES FOR THE PRIVILEGE OF ENGAGING IN WORK ACTIVITIES WITHIN THE CITY OF DRY RIDGE, KENTUCKY; AND ALSO AMENDING THE OCCUPATIONAL LICENSING FEE ORDINANCE INITIAL, NO. 604-2000, AT SECTIONS THREE AND FIVE THEREOF, RESPECTIVELY, TO PROVIDE FOR AMENDMENTS THERETO REFLECTING AN INCREASE OF THE EMPLOYEE-LICENSING FEE AND A NEW, EFFECTIVE DATE OF THE SAID INCREASED FEE LEVY SO DULY ADOPTED AND ENACTED PURSUANT TO AND UNDER THE AUTHORITY OF SECTION 181 OF THE CONSTITUTION OF THE COMMONWEALTH OF KENTUCKY, AND KRS 92.280(2), AND THE PROVISIONS APPLICABLE OF KRS 67.750 TO AND THROUGH KRS 67.795, ALL FOR THE HEALTH, SAFETY, WELFARE AND CONVENIENCE OF THE INHABITANTS, RESIDENTS AND CITIZENS OF THE CITY OF DRY RIDGE, KENTUCKY.

BE IT HEREBY ORDAINED BY THE CITY OF DRY RIDGE, KENTUCKY, AS FOLLOWS:

GENERAL ARTICLE ONE

(1) City of Dry Ridge Ordinance No. 604-2000 concerning the establishment and levy of an occupational license fee on employees for the privilege of engaging in work activities within the City of Dry Ridge as heretofore ordained and becoming operative on May 1, 2000, together with City of Dry Ridge Ordinance No. 710-2007 enacted on April 2, 2007, and Ordinance No. 730-2008 enacted on July 7, 2008, be and the same are each hereby duly reaffirmed, readopted and re-ordained save as hereby amended.

(2) That City of Dry Ridge Ordinance No. 604-2000 concerning employee occupational licensing fees as heretofore adopted and ordained and herein above reaffirmed, be and the same is hereby amended as follows, to-wit:

"SECTION THREE"

"SECTION FIVE"

Levy of employee occupational licensing fees...

For the privilege of being employed or engaged in any occupation, business, trade, profession, or other activity within the City of Dry Ridge as an employee, the employee shall pay an occupational licensing fee of ~~one-half percent (1/2%)~~ one percent (1.00%) of all wages, salaries, commissions, or other compensation earned by such employee in the city for work done or services performed or rendered within the City of Dry Ridge, Kentucky.

GENERAL ARTICLE TWO

Severability...

Each section and each provision of each section of this ordinance are severable; and if any provision, section, paragraph, sentence or part thereof, or the application thereof to any person, licensee, class or group, is held by a court of law to be unconstitutional or invalid for any reason, such holding shall not affect or impair the remainder of this ordinance, it being the legislative intent to ordain and enact each provision, section, paragraph, sentence and part thereof, separately and independently of the rest.
