### City of Dry Ridge Utility Service User Guide

\*Due Date: 15th of month (if falls on weekend or holiday due next business day). If you do not receive your bill, it is still due by due date. Bills are mailed out at least by the first (1st) business day of the month (if not before), if you do not receive your bill, please call the office at 859-824-3335 for amount or log into your account to view your bill.

- \*Payment types: Cash, Money Order, Check, and Credit Card (convenience fee will apply to cards).
- \*Retuned Check: Charge of \$35.00 for all returned checks, paper or electronic. Returned checks will be treated as non-payment resulting in penalties and services turned off. <u>After two (2) returned checks</u>, they will not be accepted for the account.
- \*Penalty: If not paid in full by 5pm on the due date, a ten percent (10%) penalty will be applied to the account.
- \*Turn off: If not paid in full by 5pm seven (7) days after the due date, the account will be charged a \$35.00 service fee and will be disconnected. NO ADDITIONAL NOTICES WIL BE SENT. Guaranteed funds (Cash, Money Order, or Credit Card) will only be accepted to reconnect service. If paid online please contact office to verify receipt of payment.
- \*Utility Tax: A three percent (3%) utility tax is placed on the water portion of the bill.
- \*Sales Tax: A six percent (6%) sales tax is placed on commercial accounts.

### Water Rates Residential & Commercial:

\$26.96 first 2,000 gallons

\$12.84 per 1,000 gallons between 2,001 & 10,000 gallons

\$12.40 per 1,000 gallons for anything over 10,001 gallons

Sewer Rates Residential:

\$45.47 first 2,000 gallons

\$16.19 per 1,000 gallons over 2,000 gallons

**Sewer Rates Commercial:** 

\$64.75 first 2,000 gallons

\$16.19 per 1,000 gallons over 2,000 gallons

Trash Service: Republic Services (513) 771-4200

- Rate: \$12.60 per month / Two (2) containers are provided (if you need containers call 513-771-4200)
- Container must not weigh more than seventy-five (75) pounds.
- Collection day: Place containers out night before. They will be collected any time after midnight.

Ashley / Dixie / Sheffield / Summerfield: Set out Thursday / Pickup Friday

Taft Hwy (26-2300 City Limits): Set out Tuesday / Pickup Wednesday

Rest of City: Set out Monday / Pickup Tuesday

- Customer owned containers must be made of plastic or galvanized steel and have handles. Do not use household containers, bushel baskets, or fifty-five (55) gallons drums or the like of any.
- Service will be provided on normal collection day with the exception of Christmas Day and New Year's Day. If collection day falls on those two days, collection will be delayed by one (1) day.
- -Large items pick up is available for additional charges. Contact above number to schedule & pricing.

# (LANDLORDS OR OTHER ACCOUNTHOLDERS OF MULTI-UNIT DWELLINGS SERVED BY A SINGLE METER (MASTER METER) USE THE MULTI-METER DECLARATION OF DOMICILE)

In accordance with the provisions of KRS 139.470(7) this declaration may only be executed for the purchase of sewer services, water, and fuel by Kentucky residents for use in heating, water heating, cooking, lighting, and other residential uses. "Fuel" shall include but not be limited to natural gas, electricity, fuel oil, bottled gas, coal, coke, and wood.

\* KRS 139.470(7) describes a place of domicile as "the place where an individual has his or her legal, true, fixed and permanent home and principal establishment, and to which, whenever the individual is absent, the individual has the intention of returning."

#### **Instructions**

- Submit the Declaration of Domicile to each applicable utility provider or rural electric cooperative, not to the Department of Revenue.
- Each resident may have only one place of domicile but may be listed as a responsible party for other service addresses
- The change in taxability for accounts will be effective on the first day of the first full billing cycle after the date of receipt of this declaration by the utility provider or rural electric cooperative.
