## RESOLUTION NO. 215, 1963

A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF DRY RIDGE, KEN-TUCKY, TO PREPARE AND EXECUTE "APPLICATION FOR FEDERAL GRANT FOR SEWAGÉ TREATMENT WORKS UNDER 33 U.S.C. 466 ET SEQ." AND APPLECA-TION FOR A GRANT UNDER PUBLIC LAW 345, 84th CONGRESS, BEING THE ACCELERATED PUBLIC WORKS ACT, AND TO SUBMIT SAME TO THE STATE WATER POLLUTION CONTROL AGENCY FOR PROCESSING IN ACCORDANCE WITH THE APPLICABLE FEDERAL PROCEDURES.

WHEREAS, the City Council for the City of Dry Ridge, Grant County, Kentucky, has determined that the City of Dry Ridge is in an area of substantial unemployment as designated by the Secretary of Commerce under Section V of the Area of Redevelopment Act and has been so designated for the last nine of the preceeding twelve months, and have further determined that the City does not have a sewage system and that it is desirable and in furtherance of the public health and safety to construct a sanitary sewage system and sanitary sewage treatment plan, and

WHEREAS, the City Council has examined a preliminary engineering report and outline of specifications for the construction of such a sanitary sewage wystem and sanitary sewage treatment plant, and after such investigation have determined that such a sanitary system is feasible with the aid and assistance

of a federal grant,

NOW, THEREFORE, be it Resolved by the City Council of

the City of Dry Ridge, Grant County, Kentucky, as follows:

THAT the Mayor be, and he is hereby authorized and directed to execute \*\*Application for Federal Grant for Sewage Treatment works" and application for a grant pursuant to Public Law 345, 84th Congress, as amended by the Public Works Act, and to file said applications with the State Water Pollution Control Agency. Frankfort, Kentucky.

THAT the City Clerk be authorized and directed to certify this Resolution prior to submission to the appropriate State and

Federal Agencies.

THAT the City Council further resolves that if a federal grant for the proposed sanitary sewage system and sanitary sewage treatment plant is approved, that the City Council will finance the remaining costs of the approved profect and will provide efficient operation and maintenance of the approved project after completion thereof, and that they will take all necessary steps to carry out the purpose and intent of this Resolution!

This Resolution shall take effect and be in full force and effect, when passed, approved, published, and adopted according to law.
