## RESOLUTION NO. 216

A RESOLUTION AND ORDER OF THE CITY OF DRY RIDGE, KENTUCKY AUTHORIZING AND DIRECTING THE MAYOR TO EXECUTE ON BEHALF OF THE CITY OF DRY RIDGE THE CONTRACT FOR THE SALE TO THE CITY OF WILLIAMSTOWN OF APPROXIMATELY ONE MILE OF FOUR INCH WATER MAIN AND EASEMENTS OVER AND THROUGH WHICH SAID WATER MAIN RUNS, ALL WATER METERS LOCATED THEREON AND ALL OTHER APPURTENANCES FOR THE SUM OF SEVENTEEN HUNDRED FIFTY (\$1750.) DOLLARS.

Whereas, the City of Dry Ridge did preciously contract to sell to the City of Williamstown approximately one mile of water main in the event the city of Williamstown should annex the territory served by said main, and

Whereas, the City of Williamstown did contract to purchase said water main, and

Whereas the City of Williamstown and the City of Dry Ridge have arrived at a decision as to the Value of said water main.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DRY RIDGE, KENTUCKY:

SECTION 1

The Mayor and City Clerk of the City of Dry Ridge, Kentucky are hereby authorized and directed to execute and deliver to the City of Williamstown the following contract:

## CONTRACT

THIS INDENTURE OF CONTRACT made and entered this 5th day of November, 1963, by and between THE CITY WILLIAMSTOWN, Party of the First Part, and THE CITY OF DRY RIDGE, Party of the Second Part:

WITNESSETH: Whereas, by a certain Indenture of Contract dated the 18th day of February, 1952, the parties hereto did contract that in the event the party of the first part annexed certain land north of its then city limits then the party of the second part would sell and the party of the first part would buy so much of the four inch water main as was included in the northward extension of the city limits of the City of Williamstown and extension of the city limits of the City of Williamstown, and
Whereas, the party of the first part has now extended its
city limits to encompass the territory mentioned in said contract,

and

Whereas, the parties have agreed upon the purchase price of said water main.

The parties do mutually agree as follows: The City of Dry Ridge does by these presence sell, alien, transfer and convey to the City of Williamstown at the expense of the City of Williamstown approximately one mile of the four inch water line, extending from the present metering station to the north corporate limits of the City of Williamstown together with all easements over and through which said four inch water line is laid, all meter connections thereto and all customers located thereon together with any and all appurtenances to said four inch water line which may lie within the present corporate limits of the City of Williamstown.

In consideration whereof the City of Williamstown Shall pay to the City of Dry Ridge the sum of Seventeen Hundred Fifty (\$1750.) Dollars on or before the 5th day of December, 1963.

It is further mutually agreed between the parties that the present metering station shall be moved from its present location to the north corporate limits of the City of Williamstown at the expense of the City of Williamstown, Kentucky.

IN WITNESS WHEREOF, the parties have hereunto set their hand the day and year first above written.

## SECTION 11

The Mayor of the City of Dry Ridge, Kentucky, is hereby authorized and directed to execute and deliverate the City of Williamstown, Kentucky, a deed of conveyance conveying all of the property rights, privileges and appurtenances described in the foregoing contract. Upon tender to the City of Williamstown of said deed, the City of Williamstown, will pay to the City of Dry Ridge the sum of Seventeem Hundred Dollars (\$1750.).

## SECTION 111

This resolution shall be in full force and effect from and after its adoption and approval as provided by law.

ADOPTED BY THE CITY COUNCIL OF THE CITY OF DRY RIDGE, KENTUCKY, on the 5th day of November, 1963; on the same occasion signed by the Mayor in open session as evidence of his approval, attested under seal by the City Clerk, and declared to be in full force and effect.
