ORDINANCE NO. 1230

AN ORDINANCE ANNEXING THE HEREIN AFTER DESCRIBED TERRITORY TO THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY.

Whereas, the city council for the city of Dry Ridge, Grant County, Kentucky, did on August 3rd. 1965 pass ordinance #229 proposing to annex the herein after described property and;

Whereas Ordinance #229 was properly published and advertised and no protest, or remonstrance has been filed in the Grant Circuit Court protesting the proposed annexation within a thirty day period;

Now, therefore the City Council for the City of Dry Ridge, Grant County, Kentucky does ordain as follows:

SECTION I

That the herein after described property be, and the same is hereby annexed to and made a part of the City of Dry Ridge, Grant County Kentucky.

Beginning at the present city limits on Kentucky Highway #22 (Taft Highway) and at a corner to tract #3 and the Taft Highway, thence North 33° 26' West 311.3 feet to a point, thence South 78° 4' West 55.3 feet to a point, North 37° 49' West 23.7 feet to a point, thence North 37° 49' West 100 feet to a point, thence South 49° 21' West 334.8 feet to a point, thence North 40° 36' West 216.6 feet to a point, thence North 37° 11' West 109.3 feet to a point, thence 49° 09' West 668.0 feet to a point, thence South 16° 1' East 566.1 feet to a point, thence North 44° 09' East 180.0 feet to a point, thence North 48° 25' East 400 feet to a point, thence North 49° 14' East 195.1 feet to a point, thence South 40° 11' East 200 feet to a point in the right of way of Kentucky Highway #22 North 56° 14' East 208.6 feet to a point of beginning, containing twelve and nine hundredths acres (12.9A) more or less and designated as Track No 1 on the plat of Stith Subdivision #3 recorded in Plat Book 3, page 5 in the County Court Clerk of Grant County.

Beginning at the present corporate limits of the City of Dry Ridge at Kentucky Highway #22 (Taft Highway) and at a corner to the right of way of Kentucky #22 and lot #1, thence North 40° 11' West 200 feet, thence South 49° 14' West 195.1 feet to a point, thence S 38° 14' East 200 feet to a point in the right of way of Kentucky Highway # 22 North 49° 49' East 200 feet to the point of beginning and designated as Track No. 2 on the plat of Stith Subdivision # 3 recorded in Plat Book 3, page 5 in the office of the County Court Clerk of Grant County, Kentucky.

SECTION II

This ordinance shall take effect and be enforced and effective when passed, approved, and published as required by law.
