ORDINANCE NO.232, 1965

AN ORDINANCE PROPOSING TO ANNEX CERTAIN UNINCORPORATED TERRITORY LYING IN GRANT COUNTY, KENTUCKY, AND BEING AD* JACENT AND CONTIGIOUS TO THE PRESENT CORPORATE LIMITS OF DRY RIDGE, GRANT COUNTY, KENTUCKY, AND ACCURATELY DESCRIB-ING THE BOUNDRY OF THE TERRITORY PROPOSED TO BE ANNEXED.

WHEREAS, the City Council for the City of DryRidge, Grant County, Kentucky, has determined that it is desirable and advantageous to the City of Dry Ridge to amnex certain territory contiguous to the present corporate limits and that no material injury will result to the persons owning real estate in the territory and that failure toso annex the hereinafter described territory will materially retard the growth and future prosperity of the City;

NOW, THEREFORE, THE CITY COUNCIL FOR THE CITY OF
DRY RIDGE, GRANT COUNTY, KENTUCKY, DOES ORDAIN AS FOLLOWS:

SECTION I

That the City Council for the City of Dry Ridge does hereby propose to annex and to make a part of the City of Dry Ridge, the following described territory lying adjacent and contiguous to the present corporate limits of the City;

Beginning at a point in the center of the inte section of Main Street (Hwy. U.S. 25) and West Broadway (Hwy.
Ky 22); thence along the center of Main Street(Hwy. U.S.25)
N 38°55° W-169.05', N16°08 W. 146.78', N 8°30 W-232.00',
N 22°57 E-334.45 and N 1°13 E-379.45 to a spike in the
center of Main Street(Hwy. U.S.25) thence, leaving Main
Street S 89°33' W-793.70 to a hub, thence S 3°16'W-382.52 to
a hub on the West side of Brewer's garage, thence S 5°06'
E-384.98' to a hub on the south side of Warsaw Avenue,
thence along the south side of Warsaw Avenue S 81°08' W1268.11 and S-79°55 W-285.65' to a hub on the south
side of Warsaw Avenue, thence leaving Warsaw Avenue, S
52 W-212.97' to a congrete R/W marker on W. Broadway
(Hwy. Ky. 22), thence S 9 49' W-63.55' to the center of
W. Broadway, thence along the center S 80°56' E-384.36',
N88°57' E-198.53', and N 84°57' E-1818.70' to the point
of beginning.

SECTION II

That this ordinance shall be published in the Grant County News, weekly newspaper, for four(4) consecutive weekly issues.

SECTION III

If after the expiration of thirty (30) days from the enactment of this ordinance no petition has been filed in the Grant Circuit Court protesting the said proposal of annexation, the City Council for the City of Dry Ridge shall enact an ordinance annexing the aforedescribed territory to the City of Dry Ridge and upon the enactment of the said ordinance, the aforedescribed territory shall be annexed to and become a part of the City of DRy Ridge, Grant County, Kentucky.

SECTION IV

This ordinance shall take effect and be in full force and effect when passed, approved and published as required by law.
