

AN ORDINANCE PROPOSING TO ANNEX TO THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY THE HEREINAFTER DESCRIBED TERRITORIES, SITUATED ADJACENT THERETO, SAME BEING DONE PURSUANT TO THE PROVISIONS OF CHAPTER 81 AND OTHER CHAPTERS RELATIVE THERETO OF THE KENTUCKY REVISED STATUTES.

WHEREAS, certain persons owning lands adjacent to the City Limits of the City of Dry Ridge, Grant County, Kentucky, who have sub-divided said lands, and who desire to sub-divide said lands, and other persons, have petitioned said city of Dry Ridge, that their property be annexed to and become a part of the said City of Dry Ridge, Grant County, Kentucky, and

WHEREAS, it is necessary for the growth and development of the City of Dry Ridge, Grant County, Kentucky, that the hereinafter described lands be annexed to the City of Dry Ridge, Grant County Kentucky

NOW THEREFORE IT IS ORDAINED BY THE CITY COUNCIL OF THE CITY OF DRY RIDGE, GRANT COUNTY, KENTUCKY, as follows:

I

Be it ordained by the City Council of the City of Dry Ridge, Grant County, Kentucky, that notice is hereby given of the proposed annexation that the City of Dry Ridge, Grant County, Kentucky, of the following described territories, to-wit:

DESCRIPTION FOR PROPOSED ANNEXATION(Area No. 1)

Beginning at a point in the present city boundary, said point being a corner to O. E. Poore and the annexation to the city by Ordinance No. 202, said point also being N 84-00 W 524.4 feet from the north-east corner of the Poore tract; thence in a westerly direction across the lands of O. E. Poore, Kentucky Department of Highways (I-75 right-of-way) and O. E. Poore in that order for a distance of 4,270.0 feet, more or less, to a common corner of O. E. Poore, W. O. and E. J. Blackburn and Harvey Hopperton; thence along the line between W. O. and E. J. Blackburn and Harvey Hopperton in a westerly direction, 148.5 feet to a common corner of W. O. and E. J. Blackburn, Harvey Hopperton and Eugene Hopperton; thence along the line between Eugene Hopperton in a westerly direction a distance of 740.0 feet, more or less, to a corner of Eugene Hopperton and Harvey Hopperton; thence extending that same line 2,790.0 feet, more or less, over the lands of Eugene Hopperton, W. O. Blackburn and Eugene Hopperton, in that order, to a point in the southwest property line of Eugene Hopperton and common to Thurman Whitton; thence in a northwesterly direction 1,570.0 feet, more or less, over the lands of Thurman Whitton to a common corner of Thurman Whitton and Edwin C. Gibson, said corner being S 8-10 E, 615.1 feet form the northwest corner of the Whitton tract; thence in a northerly direction 1,750.0 feet, more or less, over the land of E. C. Gibson to a point, a corner in

his west property line in a northerly direction 465.0 feet, more or less, to a point in his property line, said point being a corner of the present city boundary as annexed by Ordinance No. 231; thence along the present city boundary as annexed by Ordinance No. 231; thence along the present southern boundary of Dry Ridge as annexed by City Ordinances Nos. 231, 230, 167, 182, 168, 147, 78, 95, 201 and 202 to the point of beginning.

II

That this Ordinance is enacted pursuant to the authority contained in Chapter 81 and other chapters of the Kentucky Revised Statutes.

III

All ordinances in conflict herewith, to the extent of such conflict are hereby repealed.
