Upon adoption of this ordinance, John Lane Ackman, Attorney at Law, Williamstown, Kentucky, City Attorney for the City of Dry Ridge, Grant County, Kentucky is hereby authorized and directed to institute suit in the Grant Circuit Ct. as provided by KRS 94.360 (2), making all owners of properties divided by Ging Sang Alley, or that portion of same to be closed, party defendants thereto and proceed as proxided by said statute and the law of the Common of Kentucky to Judgment.

All ordinances or parts of ordinances or resolutions in conflict herewith are, to the extent of such conflict, hereby repealed.
