#### ORDINANCE NO.271

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF DRY RIDGE, KENTUCKY, RELATING TO A SALARY SUPPLEMENT FOR THE POLICE OFFICERS.

WHEREAS, the City of Dry Ridge recognizes the creation of a new section of Kentucky Revised Statues Chapter 15, and

WHEREAS, that new section, KRS 15.410 to 15.510, enables local units of government to participate in a state provided monetary incentive program and a training and educational program for local law enforcement officers; and

WHEREAS, the City of Dry Ridge recognizes the need to upgradee its law enforcement capabilities through participation in said training, education and salary incentive programs; and

WHEREAS, the City of Dry Ridge believes that by participation in such programs, it will be better able to attract competent.

highly qualified young people to the field of law enforcement and to retain qualified and experienced officers for the purpose of providing maximum protection and safety to the citizens of, and the visitors to this City of Dry Ridge;

NOW THEREFORE, the City Council of Dry Ridge does ordain as

follows:

#### SECTIONI

The City of Dry Ridge hereby declares its intention to participate in the Law Enforcement Foundation Program established by KRS 15.410 to 15.510.

## SECTION II

Each officer of the City of Dry Ridge Police Department shall be paid from the City of Dry Ridge funds an annual salary of at least \$4.350. based on a standard work year of 2.080 hours beginning no later than July 1, 1973.

SECTION III

Each officer employed on or after July 1, 1973, shall have as

a minimum educational attainment a high school degree, or its equivalent as determined by the Kentucky Law Enforcement Council.

Each officer employed on or after July 1, 1972, shall within one year of his date of employment complete a basic training course of at least 400 hours duration at a school certified or recognized by the Kentucky Law Enforcement Council.

SECTION IV

Each officer, whether originally employed before or after July 1,1972. shall successfully complete each year anin-service training course of 40 hours duration appropriate to his rank and responsibility at a school certified or recognized by the Kentucky Law Enforcement Council. Each officer shall receive in each calendar year five days tim off with pay for the purpose of taking the required in-service training.

## SECTION V

No officer shall have his base salary reduced or be denied a normal salary increase to which he is otherwise entitled because of the salary incentive payments provided by the Kentucky Crime Commission under KRS 15.410 to 15.510.

## SECTION VI

The Police Department of the City of Dry Ridge and each officer thereof shall comply with all provisions of law applicable to local police, including the transmission of data to the Bureau of Criminal Information and Statistics as required by KRS 17.150.

# SECTION VII

The Chief of the Police Department of the City of Dry Ridge shall prepare or cause to be prepared such quarterly and other reports as may be reasonably required by the Kentucky Crime Commission to facilitate administration of the funds and further the purpose of KRS 15.410 to 15.510.

# SECTION IX

The Treasurer of the City of Bry Ridge shall deposit in an apporpriate account which can be identified saparately from all other sources all momies received under KRS 15.410 to 15.510.

Forthwith upon receipt of any monies under KRS 15.410 to 15.510 the TReasurer shall pay to each police officer, giving to each officer a check stub or receipt on which the gross amount ofmonies paid to him under KRS 15.410 to 15.510 is included and identified.

All financial records relating to monies received under KRS 15.410 to 15.510 shall be retained for a period of Three years and until the completion of an audit approved by the Kentucky Crime Commission and the United States Enforcement assistance administration.

## SECTION X

This ordinance shall be published in the Grant County news, Williamstown, Kentucky for one (1) week beginning with the issue of May 4. 1973.
