
Subject: CMRS Audit

The Commonwealth of Kentucky, Governor's Office For Technology, Commercial Mobile Radio Service Emergency Telecommunications Board (CMRS) has contracted with Carpenter, Mountjoy & Bressler, PSC (CMB) to perform an audit of their financial statements for the period beginning July 1, 2002 and ending June 30, 2004. As part of this audit we are required to select a sample of PSAPs in which to verify the number of wireless E911 calls received and verify that monies received from CMRS under KRS 65.7631 were disbursed in compliance with the guidelines set forth by that statute.
