Emergency Purchase Authorization

CITY OF DRY RIDGE, KENTUCKY DECLARATION OF EMERGENCY

WHEREAS, the City of Dry Ridge, Kentucky provides ambulance service to the citizens of the City as well as citizens of Grant County, Kentucky;

WHEREAS, in or about May 2015 the City of Dry Ridge, Kentucky lost service of two of the City's three ambulances;

WHEREAS, the City has made several attempts to bring said ambulances back into service;

WHEREAS, on multiple occasions one or both of the ambulances have/has been taken back out of service despite repairs being made;

WHEREAS, funds for the purchase of an ambulance have been included in the City's budget;

WHEREAS, the Mayor has consulted with the heads of the effected departments;

WHEREAS, the absence of one or more of the ambulances may result in serious injury or loss of life; and,

WHEREAS, the loss of ambulance service severely impacts the public health, safety and welfare and is detrimental to same.

NOW, THEREFORE, I, James Wells, Mayor of Dry Ridge, Kentucky, by the authority vested in me by KRS 424.260(4), do hereby declare that a local State of Emergency exists in Dry Ridge, Kentucky for the period of time the City is without the service of one or more of its ambulances, and direct that:

1. The City of Dry Ridge, Kentucky, shall acquire a **USED** ambulance as soon as reasonably possible.
2. Central Campbell County Fire District has declared one of their ambulances surplus.
3. The City submitted a sealed bid in th amount of \$37,300.
4. Said bid was accepted by Central Campbell Fire District.
5. Under this State of Emergency, the Mayor has the authority to waive procedures and formalities otherwise required by law pertaining to: a) entering into contracts; b) incurring obligations; c) purchase and distribution of supplies, materials, facilities and equipment; and, d) appropriation and expenditure of public funds.
