

A. PLANNING & ZONING TEXT AMENDMENTS (2ND READING)

1. 806-2016 Central Business District

NEW BUSINESS

A. KAY GATEWOOD

Ms. Gatewood who lives on Wilorn Drive addressed council regarding the 4-wheelers and go carts being driven on the road. Ms. Gatewood stated the children have these items out when the weather is nice.

Ms. Gatewood stated she has complained in the past about this issue and would like to know why it has not been resolved.

Council member Kenny Edmondson stated the police have been called in the past concerning this and that he himself have talked to the children involved.

Attorney Pete Whaley stated the incidents may be able to be classified under a noise issue or possible safety issue.

Chief Rick Kells stated in order for the police department to site them, they must witness the children riding the 4-wheels or go carts.

Mayor Wells stated it is a state law that they cannot ride on the road.

Chief Kells instructed Ms. Gatewood to call 911 anytime she saw the children riding on the road. This would allow for a record to be kept regarding each incident.

Mayor Wells asked Attorney Whaley to draft a letter to the residents to see if a resolution can be had.
